Tēnā koutou katoa,

Kāore i tino roa ki muri, ka whakaarotia e te tini o te tangata kore rawa e mukua atu ngā kaikonihi o Aotearoa kia kaikonihi-kore te motu katoa. Ka kiā he pohewa nā te hinengaro pōauau.

Ki taku mōhio, tērā anō ētahi tāngata he pērā tonu ngā whakaaro. Engari, kāore e tika kia pēhia tō tātou piki ki ngā rangi tūhāhā nā te whakatito mai a te tangata ki tō tātou wawata nui.

He kaupapa māia a Kaikonihi Kore 2050, he kaupapa whakaoho i te iwi, hei urupare ki te rarunga kanorau koiora o Aotearoa. He wāhi nui tonu ū tatou momo taketake nō tō tātou tuakiri ā-motu, tuakiri ahurea. Ko tātou katoa kei te hāpai i tētahi wāhanga o te kupenga, e tiakina ai, e whakareia ai ngā taonga o nāianei, mō te reanga i taku tamāhine, me ngā reanga kāore anō kia whānau mai.

E ai tā te whakataukī a Tā Paul Callaghan, he kōrero e tika ana kia whakapuakina nuitia, ko tēnei whakaaro kia kaikonihi-kore Aotearoa tētahi whakaaro 'pōrangī', engari ka whakataukītia tēnei kaupapa hei rite ki te rerenga a te tangata ki te marama, ā tōna wā.

E ai ki tētahi arotakenga i ngā tau tata nei mō ngā momo māori noho whenua koni atu i te 9000, neke atu i te 3000 e mōrearea ana, he mōreareatanga rānei ka korehāhā. E urupare ana a Kaikonihi Kore 2050 ki ēnei āhuatanga i runga i te kakama. E mōhio ana mātou he tere tonu ngā koiora māori ki te hoki mai ina wātea tētahi momo i te konihi, ā, ka kitea tēnei āhuatanga ina haere mātou ki ngā moutere moana, me ngā rāhui tuawhenua hauropi whai taiepa. Kei ēnei wāhi ka kitea te āhua o Aotearoa i ngā rā o mua, ka pēhea hoki pea tōna āhua hei raurangi.

E whakawhirinaki ana a Kaikonihi-kore 2050 ki ngā mātauranga o ngā tuangahuru tau i angitu ai te haepapa kaikonihi i ngā moutere me te nui noa atu o te mātauranga hou, tae atu ki ngā mātauranga hōhonu o te hia whakatupuranga e noho tahi ana te tangata whenua me te taiao. Hei waitohu te tau 2021 mō te rima tau mai i te whakapuakitanga o te whāinga, ā, he wā tika hoki kia whakaatatia, kia whakanuia hoki te ahunga whakamua tae mai ki tēnei wā.

E kore te whāinga e tutuki i te hinonga kotahi anake, ā, me tā hou i te kupenga, kia pipiri katoa hoki ngā kaimahi, kia matawhānui kē noa atu te titiro ki tua atu i ū mua taumata. Kua whakaatatia tēnei i roto i te rautaki Kaikonihi-kore 2050, e pou nei i tētahi mahere whenua mō te eke atu ki ngā waitohu, mā te whakamahi hātepe whakahāngai i ngā haumitanga ki ngā kōkiri rangahau, me ngā kaupapa.

Ko te aronga, tae mai ki tēnei wā, he whakaoho i te iwi, he kimi tikanga hou hoki. Kawea ai ngā mahi tāmi kaikonihi e ngā rōpū hapori, i ū rātou wāhi noho, wāhi mahi, wāhi tākarō hoki. I tērā wiki tonu ka uru taku tamāhine hei mema o te karapu tārore o tō mātou takiwā tāone.

Kua whakarewaina he kaupapa haepapa kaikonihi rarahi huri noa i te motu katoa. Ka noho ēnei kaupapa hei tohu i te huarahi – e whakamātauria ai he taputapu, he tikanga mahi hou, e ako ai tātou i ngā āhuatanga e tutuki ai te haepapatanga torowhānui. Ko te arotahitanga nui, kei te auahatanga pūtaiao, rangahau hoki, i a tātou e rapu tomokanga pūtaiao hei wewete i ngā uauatanga o te haepapa kaikonihi.

He pai tō tātou ahunga whakamua ki ngā tohu huarahi tārewa o te whakatutuki me te whakapūmau i te haepapatanga i ngā rohe tuawhenua rahi kore taiepa, ā, kei runga kē atu te tāmitanga kirearea puta noa i te whenua i te ūnga mō 2025.

Ka nui te hari o te kāwanatanga ki te tū tahi me ngā hapori, ngā whānau, ngā hapū me ngā iwi, ngā umanga, ngā kaipūtaiao me ngā whakahāere ehara i te kāwanatanga ki te akiaki i te hoenga o te waka ki te whāinga whakamutunga. He roa te ara, e tika ana kia kaha tatou ki te ako, ki te tārei hoki i ūna ritenga i roto i ngā tau – engari i te mutunga, ka kitea ūna tini hua.

Tēnei a Kaikonihi-Kore 2050 te huri atu ki tētahi aronga hou, arā, ka waiho te ārainga taupua, ka timata kē i tētahi haepapatanga pūputu ā-motu whānui. He kaupapa māia tēnei, hei urupare ki te rarunga kanorau koiora o Aotearoa. He tini ngā taumata kua ekea i roto i te 5 tau mai i te hāpainga i te whāinga kia wātea a Aotearoa i ngā kaikonihi e toru tino kino te ngangau mō ō tātou koiora māori, - arā, te kiore, te paihamu, me te whānau tori, (te whereti, te toriura, me te wīhara).

Ko tā Kaikonihi-Kore 2050 he whakapakari i ngā tūāpapa i poua mai e ngā hapori i mahi nui i tēnei tū mahi hei tiaki i te taiao i tō rātou takiwā, me ngā momo koiora māori. Kei te piki haere tonu te tautoko, kei te āwhina te hunga ngākau-nui i ngā kaupapa puta noa i te motu, me te tautoko atu a te Predator Free New Zealand Trust i a rātou.

Tērā anō tōna haumitanga pūtea e te kāwanatanga, arā, neke atu i te \$300 miriona, ki nga kōkiri Kaikonihi-Kore, ā, hei taituarā tēnei mō ngā pūtea mai i ngā kaunihera ā-rohe, ngā hinonga atawhai, me te wā mahi, ngā mahi whakaheke werawera hoki a ngā rōpū hapori.

Nā Te Rautaki Kaikonihi-Kore 2050, i tāreia i te tau 2020, i whakarite tētahi kaupapa kawē kē i te ihu o te waka, whakakotahi hoki i ngā tini āhuatanga, kāore e kore ka tūponotia i raro i tētahi whāinga pēnei rawa te matawhānui. E horaina ana te Rautaki mā ngā ara mahi e ono. E toru anō hoki ūna wāhangā matua, e kitea nuitia ai te pāhekohoko ā-rohe, ā-motu i roto: whakamanawatia-whakaauahangia-whakahohorotia. E whitu ngā whāinga tārewa o Kaikonihi-Kore 2050 hei arataki i ā mātou mahi i roto i ēnei tau tūtata. Inā hoki te nui o te ahunga whakamua i raro i ēnei whāinga mō 2025.

Nā ngā haumitanga a te Kāwanatanga ki te hōtaka tāmi kaikonihi Tiakina Ngā Manu a Te Papa Atawhai, me ngā hōtaka rohe whānui mā roto i Predator Free 2050 Limited kua tino whakawhānuitia te tāmitanga kaikonihi-kore – ki tua noa atu i te whāinga mō te tau 2025, i pikī ai te rohe tāmi kaikonihi-kore i te tuawhenua o Aotearoa mā te 1 miriona heketēa (mai i ngā tatauranga o 2016).

E hoatu ana ētahi kaupapa haepapa kaikonihi rohe whānui i ngā hua rangahau i te taiao, me te whakawhānui i tō tātou mōhio me pēhea te haepapa kaikonihi i ngā rohe rarahi, me pēhea hoki e tiakina ai ngā whenua matahuhua kei whakaakea anō. He wāhi matua tō te whānau, te hapū me te iwi i roto i ngā mahi hoaho, whakatau, hora hoki i ngā kaupapa whakahāere kaikonihi i ō rātou rohe. E rua ngā kaupapa kua whakarewaina, he iwi te kaiārahi, tae mai ki tēnei wā, ā, tērā anō ētahi e whai mai ana i muri.


Kei te paihere te hapori pūtaiao i āna mahi ki runga i ngā rangahau e pikī ai te utu, te hohoro me te matararahi o ngā haepapatanga kaikonihi. Tērā anō ētahi kaupapa rangahau, whanaketanga hoki i roto i Manaaki Whenua – Landcare Research, te Biological Heritage National Science Challenge me Predator Free 2050 Limited kua hāngai ki runga i ngā whāinga Kaikonihi Kore.

I whakatūria ai te Tools to Market (Te Papa Atawhai) me Products to Projects (Predator Free 2050 Limited), he whai kia ākina te auahatanga i te taha taputapu, hangarau hoki, me te whakawātea i ēnei hei whakamahinga mā ngā kaupapa kaikonihi-kore. Ko ngā taputapu me ngā ritenga mahi nā Zero Invasive Predators i tārei i tā rātou haepapatanga i te whānau tori, ngā paihamu, me ngā toriura i te pae o te riu o Perth, i Arawhata; tētahi huringa nui mō ā tātou whakaritenga haepapa kaikonihi, ārai pae hoki kei whakaakea anō, kāore he whakamahinga taiepa.

Me pohewa tētahi Aotearoa e noho haumaru ai ngā koiora māori, e kore e haepapatia, e hauora ana te tupu i waenga i a tātou.

He whāinga tino matawhānui a Kaikonihi Aotearoa 2050, i whakatauria i te tau 2016. Ko tōna uho kia wātea a Aotearoa i ngā kaikonihi e toru tino kino te ngangau mō ū tātou koiora māori, - arā, ngā paihamu, te whānau tori, (te whereti, te toriura, me te wīhara) hei mua i te takanga ki te tau 2050.

Mā te whakatutuki i tēnei whāinga e tino piki ake ai te kanorau koiora o Aotearoa, e piki ake ai hoki te hauora o ū tātou momo koiora e kīa nei he taonga, pēnei i ngā manu, i ngā pekapeka me ngā kararehe kōiwi kore, kātahi anō ka pēnei te mataora i waenga i a tātou.

Ka noho Kaikonihi-Kore 2050 hei whāinga whakakotahi i ngā iwi katoa o Aotearoa. Ka taea e ngā whānau, e ngā hapū, ngā tūao, ngā hinonga kāwanatanga, ngā kaunihera, ngā kaipūtaiao, ngā rōpū ehara i te kāwanatanga (NGO), te hunga ngākau atawhai, me ngā rōpū hapori hoki te whakahāngai i ā rātou mahi ki runga ki tēnei whāinga. E kore tēnei whāinga matawhānui e tutuki i te hinonga kotahi anake. Ahakoa, mā te mahi tahi ka taea e tātou te whakatutuki tētahi mea whakahirahira kē atu, tēnā i te hua o ū tātou mahi takitahi.

Ka wātea mai ana Aotearoa i ēnei kaikonihi, ka kitea te raneatanga o ngā kararehe, o ngā manu, o ngā kararehe, ā, he whenua tēnei e tino piki ai te hononga o te tangata ki te taiao. Kei te tohu i tāreia mō Kaikonihi-Kore 2050 te matakite nei: Tuia Te Taiao, Ko te Tangata – Ko Te Taiao, Kia haere takitahi.

He aha tātou i hiahia ai ki tēnei whāinga?

Mā tētahi Aotearoa wātea i ngā kaikonihi, ka whakarauorangia ō tātou manu, kararehe i te korehāhātanga, ka tū tika anō te mauriora o te taiao, ka noho hei taonga mō ngā reanga hou. Ko Kiwi tērā, ko Kererū tērā, ko Tuatara tērā, ko Wētā tērā – he wāhanga taketake ēnei momo o te taiao nō tō tātou noho i te ao, ā tātou pūrākau, tuakiri hoki.

I whanake mai ō tātou kararehe iwi-kore i roto i te 80 miriona tau ka hipa, kāore he kaikonihi whāngote, nā konei ka noho mōrearea ki ngā kaikonihi i kawea mai i tāwāhi. Kua ngaro ētahi momo mō ake tonu atu – mai i te taenga mai o te hunga tangata ki konei, 79 ngā momo e mōhiotia ana kua korehāhā, e 59 o ēnei he momo manu.¹

I tēnei wā, 74% o ngā manu noho tuawhenua māori o Aotearoa, me tētahi 84% o ā mātou momo mokomoko māori, kei te noho mōrearea, kua tata te korehāhā.² E ai te kī, kua tū ā-tō te rā, me huri wawe tātou ki te tiaki i ēnei momo, i runga i te mōhio neke atu i te 25 miriona manu māori ka patua ia tau e ngā kaikonihi nō tāwāhi.³

E ai tā te Māori, ina ngaro te mauri, ka pākia te wairua o te tangata, ka hinga te mana o te iwi, ka tānoatia anō hoki ko te tapu o te taiao. Mehemea e hē ana te taiao, ka noho ngoikore tātou katoa. E tūhonohonotia ana te hauora o te tangata me te taiao.⁴

Ka whakaatatia e Kaikonihi-Kore 2050 te whāinga mātāmua a te Kāwanatanga kia tiakina, kia whakatikaina, kia whakaorangia hoki ā tātou taonga ā-taiao, me te kanorau koiora. Hāunga ia te pānga taumaha o ngā kaikonihi ki ō tātou momo e kī nei he taonga, he mōrearea hoki ngā kaikonihi mai i tāwāhi ki tō tātou hauora, ki te ūhangai me te rāngai ahuwhenua – ina hoki, he kaikawe ēnei momo mō ngā mate hōrapa pēnei i te mate kohi o te kau.

Hei pēhi te tāmitanga kaikonihi i te maha o ngā kaikonihi ki tētahi taumata pāpaku, e iti iho ai te kinonga, otia ko tā te haepapa, he patu rawa i tētahi momo kaikonihi mō ake tonu atu. Mā te haepapa kaikonihi ka whai putanga anō ō tātou momo māori, kāpā kia ora noa iho, engari kia puāwai. Ko te mate o te huarahi tāmi tonu, he huarahi e hokihoki pūputu ai tātou ki ngā haumitanga pūtea, whakamahi paihana, tārore kararehe, engari ia te haepapa hei whāinga, ka taea pea te whakamutu rawai i ēnei hokinga ki aua mahi.

Ehara tēnei i te mahi māmā – kāore anō he kaupapa haepapa kaikonihi pēnei te rahi kia tutuki i te ao nei. Kāore kau he pukapuka hei whai, engari arā noa atu ngā whiwhinga. Mā te ekenga ki te taumata ka puāwai te hononga o te tangata ki te taiao, me ngā momo māori. Ka piki te maha o te hunga tāpoi peka mai ki Aotearoa, ki te whakangahau ki tō tātou taiao ātaahua, kore kaikonihi hoki. Ka piki kē noa atu te rāngai tūmatanui, i te korenga e herea e ngā ritenga whakahaeere kīrearea, ā, ka taea tō tātou mātauranga tāmi kaikonihi, waihoki ō tātou pūkenga, taputapu hoki, te tuku ki whenua kē puta noa i te ao.

He wāhanga tō ngā tāngata katoa i tō tātou whenua kia tutuki Aotearoa Kaikōnīhi-Kore. E piki ana Kaikōnīhi-Kore 2050 hei kōkiri talao, pāpori torowhānui, e tuia ai ngā kaupapa rerekē hei mea kotahi, e tutuki ai ētahi whāinga tino hira.

He whāinga ā-motu Kaikōnīhi-Kore 2050, ko tōna tīmatanga mai ko ngā kōkiri ā-hapori ki ngā haepapatanga ā-motu, me ngā tāmitanga i te tuawhenua nā ngā rōpū hapori, me ngā rōpū ehara i te kāwanatanga i roto i te 60 tau ka hipa ake nei.

Ka nuku haere te paihamu, te kiore, te toriura, te wīhara me te whereti i waenga i ngā whenua whāoomomo, ngā whenua pāmu, ngā punanga ā-rohe, ngā kāinga noho, me te wāhi pakihī matua o te tāone. E hiahiatia ana kia paiheretia ngā whakapaunga kaha o te tini o ngā rōpū me ngā tāngata whakaaro ōrite, whāinga ōrite, e tutuki ai i a tātou te tū kaikōnīhi-kore. Kaua e waiho tēnei whāinga mā te hinonga kotahi e kawe – he kōkiri tēnei ka taea te hāpai e ngā kairangahau, e ngā whakahaere me ngā rōpū, ahakoa te wā.

I te takiwā paetata, kei te tuia mai e ngā hapū, ngā iwi, e ngā hapori, e ngā umanga me ngā kaunihera ki roto i ā rātou kōkiri take, hei whakaora i te taiao, hei whakapiki i te toiora tangata i ū rātou takiwā noho.

I te taumata ā-motu, tērā te huhua o ngā kaipupuru pānga puta noa i te kāwanatanga, i ngā hinonga Karauna, i ngā rōpū ehara i te kāwanatanga, i te rāngai atawhai hoki e whakahāngai nei i ā rātou mahi ki runga i ngā whāinga-poto me ngā whāinga-roa i whakatauria i raro i te Rautaki Kaikōnīhi-Kore 2050.⁵ E eke ai ēnei whāinga me ngā mahi matatini o roto, me tino pāhekoheko ngā rōpū ā-motu, inā hoki kātahi anō he kōkiri pēnei ka tīmataria.

Rautaki Kaikonihi-Kore 2050

Ka tautokona e te Rautaki tētahi ara pāhekoheko, rōpū maha ki te whāinga o Kaikonihi-Kore 2050, me te tuku mā ngā hinonga, ngā whakahaere me ngā rōpū hapori takitahi e kawe haere i ngā mahi e tino mahia ana e rātou.

He pēhea i tāreia ai te Rautaki?

Nā te mea ko te Papa Atawhai (COD) te hinonga hautū a te Kāwanatanga mō Kaikonihi-Kore 2050, nāna i ārahi te tāreitanga o te Rautaki. I whakatūria ētahi hui tuatahi i te tau 2018, i pōwhiritia ai ētahi tāngata takitahi i ngā rāngai maha kia horaina he tohutohu mō te ahunga rautaki, waihoki ō rātou mōhiotanga mō ngā wehenga o te kaupapa. I whai wāhi mai ngā kaipūtaiao, a Predator Free 2050 Limited, Predator Free New Zealand Trust, ngā rōpū whāomoomo ehara i te kāwanatanga, ngā kanohi kaipakihi, me ētahi māngai nō ngā iwi me Ngā Whenua Rāhui.

He mea taketake kia whai wāhi mai ngā whānau, ngā hapū me ngā iwi ki te tāreitanga o te Rautaki, me tā rātou tohutohu mai he mea nui te 'pēheatanga' o ngā mahi, he rite tonu tōna hira ki te tutukinga o te whāinga. I whakatūria he hui i ngā rohe 15, neke atu o te motu, ā, neke atu i te 100 ngā iwi, ngā hapū, me ngā rūnanga i pōwhiritia kia tae ake. Nā konei ka hōhonu kē atu te māramatanga ki ngā moemoeā o ngā whānau, ngā hapū me ngā iwi hei kaitiaki, ā, ka whakaurua atu ki te Rautaki.

I noho anō ēnei urupare hei kahupapa mō te aratohu whakawhiti kōrero, kia pai ai te whakaputa kōrero o ngā tāngata katoa. I haere ngā toronga whakaaro tūmatanui i roto i ngā tau 2018/2019, ā, 742 ngā urupare uiuinga i tae mai, 161,663 ngā tāngata i torona mā te pāhopori (4300 ngā puakitanga whakaaro/whakawhitinga nā roto i te pāhopori). He wāhi nui tonu tō ngā urupare i tae mai, mā roto i te toronga tūmatanui, nō te hanganga o te Rautaki.

He aha tēnei mea te Rautaki Kaikonihi-Kore 2050?

He wāhi anō te Rautaki nō tētahi urupare kanorau koiora whānui kē atu, e poua nei ūna āhuatanga i roto i Te Mana o te Taiao - Aotearoa New Zealand Biodiversity Strategy 2020.⁶ He wāhi hira anō te haepapa kaikonihi nō te whakatika i te hekenga kanorau koiora.

He mea āta hoahoa te Rautaki me te Mahere Kōkiri 5-tau i te taha kia whakahāngaitia, kia rurukutia ngā mahi whāomoomo taiao, te haumaru koiora, te kanorau koiora hoki puta noa i te kāwanatanga ā-motu, te kaunihera ā-rohe, ngā hapori, ngā whānau me ngā iwi. Tērā ētahi kawenga kētanga me mātua whakatinana, mō te āhua o tā tātou mahi kōtui, tā tātou ako, pāhekoheko hoki, ka pēhea hoki e whakaotingia ai ngā whakatau.

I runga anō i te āhua wātaka-roa te whāinga o Kaikonihi-Kore 2050, o ngā rangahau me ngā auahatanga e tika ana kia tae atu ki reira, ka tākinā i roto i te Rautaki ētahi wehenga e tika ana kia whakaraupapatia ā tātou mahi i roto i te wā.



Ka uru ki ēnei rōpū ngā mema o te hapori Kaikonihi-Kore 2050, ā, kua whai haepapa ā-motu tā rātou mahi mō tēnei kaupapa, otirā, he mahi tēnei e tika ana kia whakahāngaitia te whāinga rawa me ngā mahi.

I tēnei wā neke atu i te 50 ngā tāngata mai i ngā whakahaere, i ngā hinonga me ngā rōpū 27, kua huia mai kia mahi i roto i ētahi rōpū pāhekoheko e ono. E hanga ana ēnei rōpū i ētahi mahere mahi hei tautohu i te ahunga ihu waka mō ia ara, hei whirinakitanga hoki mō te anga mahere haumi ka tīkei ki ngā hinonga me ngā whakahaere o roto, me te whakaoti ritenga e haere tika ai te whāngaitia pūtea ki te whakatutukitanga o te Rautaki.

E takoha ana ngā kaunihera ā-rohe puta noa i Aotearoa ki Kaikonihi-kore 2050, mā roto i ā rātou mahi tamai kaikonihi o ia rā, o ia tau, i roto i ngā rohe. E matapaetia ana ko te huinga o ngā haumitanga a te kāwanatanga ā-rohe, he neke atu i te \$26 miriona i te tau.

Kei waho i tēnei tātainga ngā rohe e tāmia tonutia ana ētahi atu momo kaikonihi e Te Papa Atawhai, waihoki ngā mahi tāmi kaikonihi i raro i ētahi atu whakahaere, hinonga rānei pēnei i OSPRI, ngā kaunihera ā-rohe, ngā rōpū hapori rānei, te tikanga o tēnei tērā noa ake pea te pikinga tōpū o ngā takiwā e tamia tohutia nei ngā kaikonihi mai i 2016.

E ai ki ngā raraunga mai i ngā pūrongo ā-tau a Te Papa Atawhai, i ngā tau 2015/2016, i kawea ngā mahi tāmi paihamu i ngā heketēa 773,233.⁹ I te mutunga o te tau i mutu ake i te 30 Pipiri 2020, ko taua inenga kua piki ki te 1,576,000 heketēa. Te tikanga o tēnei, tērā tōna 802,767 heketēa tāpiri e kawea nei ngā tāmitanga paihamu e Te Papa Atawhai, mai i 2015/2016 – ā, ko te nuinga o tēnei pikinga ake nā te haumitanga kaha ake ki te hōtaka tāmi kaikonihi e kīa nei ko Tiakina Ngā Manu. Mai o tōna whakatūranga i te tau 2016, kua haumi a Predator Free 2050 Limited ki ētahi kaupapa haepapa kaikonihi, tāmi kaikonihi rohe whānui, puta noa i te motu. I te marama o Haratua 2021, e 281,000 heketēa e kawea ana ngā tāmitanga kaikonihi tūmau, mā roto i ngā kaupapa e whai wāhi nei a Predator Free 2050 Limited.¹⁰

Te Horopaki

Te kaupapa kei muri i tēnei whāinga, he whakaū i tā tātou tiaki i ngā takiwā me ngā momo e tino mōrearea ana, ko te whakaaro, kia 'nui ngā mahi ka oti i roto i te wā poto, kei waipuketia tātou e te takanga o te wā' i ngā hangarau nei e whakawhanaketia ana.

Ahakoa ko te whāinga whakamutunga o te Kaikonihi-Kore he haepapa i ngā kaikonihi katoa, he mea nui te tāmitanga i ēnei tau nei. Tā tēnei hanga he whakaū tikanga e whakaaro ai tātou mō te ūnga ki uta – ngā mea e hiahia nei tātou kia whakaorangia, me te whakaū tikanga e noho mai ai he taupori hauora, e puāwai mai he taupori hou i ētahi atu wāhi ina noho kaikonihi-kore.

Me kī, ko tōna tikanga ngāwari rawa he whakaheke, he whakahaere rānei i te maha o ngā kaikonihi (me ngā pānga) me te tāmi kaikonihi kia kaua ai e piki ki runga i tētahi taumata i āta whakaritea. Atu i tēnei rā me haere ki hea

Hāunga te tāmitanga, ehara te haepapa i te tāmitanga kaha noa iho – ko tōna whāinga kia haepapatia rawatia ngā kaikonihi katoa. Ehara i te mea ka taea te whakamahi ngā tikanga hei tāmi hei whakahaere rānei i ngā kaikonihi te whakapiki noa kia haepapatia te taupori. He tino rerekē ngā tauira e rua, arā, te tāmitanga me te haepapatanga, ā, me rerekē ngā tikanga whakamahere, whāngai pūtea hoki ki ngā mea e rua.

I te whakaritenga o te whāinga, i whakaarotia me homai tētahi 1 miriona heketea tāpiri, whakapiki atu, whakapiki atu, hei rahi tōtika e 'mau ai te taura' kia kaua e hāngengangenga te tū ki ngā kaikonihi, me te kaupare i ā tātou momo taonga, i a tātou e whakawhanake rautaki nei mō te haepapa. Te Whāinga: Hei te 2025, kua whakaaturia ka taea te ārai kaikonihi i ngā wāhi o te tuawhenua o Aotearoa he 20,000 heketea te rahi, ā, ka taea hoki te kaupare tonu i te hokinga mai o te kaikonihi ahakoa kāore he taiepa i whakamahia.

Te Aromatawai

I runga anō i te ahunga whakamua tae mai ki nāianei, me ngā kaupapa whai pitomata kei mua tata, kua tata tēnei whāinga te whakatutuki i mua i te tau 2025. Kua tutuki te haepapatanga paihamu, toriura, (me ngā kiore kia tino iti noa te mahā) i te whakamātautau kaupapa a Zero Invasive Predators (ZIP) Perth River, i tētahi takiwā 12,000 heketea te rahi.

Kua tū ā-tutuki te haepapatanga paihamu i Te Māhia, i Whakatipu Māhia Peninsula (14,500 heketea) i mua i 2022. He mea taketake te kaha o ēnei kaupapa ki te ārai i ēnei wāhi i te whakaekenga anō i roto i ngā tau, mō te whakatutuki i tēnei whāinga tārewa.

Ka puta ētahi akoranga i tēnei kaupapa i Predator Free South Westland mō te wāhanga mahi ka whai i muri, e whakawhānuitia ai tēnei rohe ki te 100,000 heketea i roto i ngā tau e tū mai nei. Ka taea te hoatu ngā akoranga ka puta i te hoahoatanga me te whakamahere o te kaupapa o Maukahuka Pest Free Auckland Island, 50,000 heketea te rahi, ki ngā takiwā rohe whānui o te tuawhenua.

Tērā anō hoki ētahi atu kaupapa e whakaranea nei i te mōhiotanga mō ngā tauārai i te whakaekenga anō. E whakamahia ana e Predator Free Wellington tētahi tauārai mariko, ko tētahi taupā ko te ara rererangi i te tauranga rererangi o Pōneke, he puna māunu i reira, he rārangi toromāhangā hoki kei ngā takiwā kāinga noho i te taha, ā, i tētahi atu pito o te tāone, kei te whakamātautau a Capital Kiwi i tētahi tauārai, he mahā ūna whatunga toromāhangā, puta noa i te kūrae katoa.

Kua oti tētahi tauārai mariko te hoahoa i te kaupapa o Taranaki Taku Tūranga, i Pukeiti, i ngā pīnanakitanga o Taranaki, me tana whakamahi i ngā toromāhangā 1,300 hei kapa ārai tuatahi, kia kore ai te paihamu e hoki mai. E tūhura ana Te Manahuna Aoraki i te riu whakarunga o Waitaki me te Whenua Rāhui o Aoraki i te whakamahinga tauārai o te whenua ake, pēnei i ngā tuahiwi maunga me ngā awa rerenga wai. E mahi tahi ana a Manaaki Whenua – Landcare Research me ēnei kaupapa, e hoatu ana hoki i ngā rangahau hangarau hei whirinakitanga mō ngā whakatau mō ngā mahi.

Ko te whāinga kei mua mō Kaikōnīhi-kore 2050, he whakarahi ake i ngā takiwā, he haepapa, he ārai hoki i aua wāhi kāore he taiepa – koia tēnā tētahi aronga taketake i muri i tēnei whāinga. E toru ngā hōtaka mahi e whakamaheretia ana hei whakatika i te whakarahinga me ngā tikanga ārai kei whakaeekeā anō: Ko Predator Free South Westland, Predator Free Rakiura/Stewart Island me Farms as Barriers.

Ina tāpiritia te kāuru o Te Whataroa ki te takiwā o te riu o Perth Valley, ka whakawhānutia ki te 20,000 heketēa neke atu, ā, ko te hipanga whai i muri tēnei mō te haepapa i ngā momo takiwā 100,000 heketēa te rahi neke atu – e taea ai te kaikōnīhi te haepapa i Aotearoa katoa. Ka uru ki te kaupapa katoa o South Westland tētahi 100,000 heketēa neke atu, ā, e whakahaeretia ana e Predator Free South Westland, he kamupene mahi aroha e mahi tahi nei me ZIP. Ka whakamahi tēnei i tētahi huarahi 'whakahaere urutau' e ako ai, e tārei ai tō rātou tira kaupapa i ā rātou tikanga, i a rātou e mahi ana.

I whakarewaina te kaupapa haepapa i ngā kaikōnīhi i Rakiura/Stewart Island (160,000 heketēa) i ngā marama whakamutunga o te tau 2020. Ka whakamahia e tēnei kaupapa tētahi ara hoahoa i mua i te whakamahere, ko ūna pou ko ngā whakamātautau i te takiwā, me te whakamahere hoahoa, hei whakaheke i te rangirua, hei whakawhanake hoki i tētahi mahere mahi, e mōhiotia ana ka puta tētahi hua nui. Ina hoki, he kāinga noho a Rakiura nō te 400 tāngata, neke atu, nā reira me mātua tautoko te hapori, me piki hoki te whakapono ki te kaupapa.

He whai take ngā ara e rua, tō South Westland (te whakahaere urutau) me tō Rakiura (te hoahoa ka hoatu i muri), ā, mā ngā hua ka taea e mātou te whakawhanake tauira hora pai rawa mō te haepapa takiwā whānui i te tuawhenua ā tōna wā.

Ko te āheinga kia āraia ngā takiwā haepapa tētahi mea taketake mō te pupuru i ngā hua, me te kite i tētahi painga mō ngā haumitanga. Ki te kore e taea e tātou te ārai i ngā takiwā, kāore e tika te whakapau moni hei haepapa kakonīhi, nā te mea, ka tupu anō i reira. E rua ngā ara e whakanaketia ana e ngā kaupapa o South Westland me Farms as Barriers.

Kei te whakamātautau a South Westland i te whakamahinga o ngā āhuatanga ahunuku pēnei i ngā awa hohoro o Te Tai Poutini, Kā Tiritiri o te Moana/the Southern Alps, me ngā tai matapari (fiord) hei tauārai. Mā tēnei tikanga ka taea ngā pūnaha ngahere īnakinaki rahi o Te Tai Poutini me Te Whakatakaka-o-kā-kārehu-o-Tamatea (Fiordland) te wāwāhi hei wehenga tōtika mō te aruturuki, me te urupare ki ngā whakaekenga anō. He tikanga tēnei ka pai i ūna rohe ahunuku anō e tika ana mō ēnei momo mahi, otirā, e kore e taea tēnei tikanga te kawe ki te nuinga o te motu.

Ko te ara tuarua ko Farms as Barriers. He kaupapa pūtaiao e whakatinanatia ana tēnei, he mea whāngai ki te pūtea e te Biological Heritage National Science Challenge me Te Papa Atawhai hei whakawhanake taputapu haepapa mō ngā whenua pāmu, e puta ai hoki he tauārai ki te nekehanga kaikōnīhi (arā, mā ngā hangaroto haepapa e patu ngā kaikōnīhi whakaeeke i mua i tōna āhei kia whakawhiti i ngā whenua pāmu ki tētahi atu taha). E tūmanakotia ana kia puta he tauira mahi hei kawe whānui ki te ao tūturu i roto i te 5 tau. Mā konei ka taea te kaupare i te tini o ngā wāhi ngahere rahi, he whenua pāmu kei ngā taha, i Te Ika-a-Māui, i Te Waipounamu, me Murihiku.

Me waihanga ngātahi tōna whakarahinga me ngā tikanga ārai kei whakaeekeā anō. Ko ēnei kaupapa hei tētahi matapae 5-tau, ā, ki te tutuki ēnei ka whai taputapu mātou hei whakarewa mahere haepapa i te nuinga o Aotearoa.

He mātai tūāhua:

Mai i Te Ārai Kīrearea ki te Haepapa i ngā Kaikonihi

He huringa tēnei atu i te pēhitanga tonutanga o ngā kīrearea, arā, te whakatōmuri tonu, ki te haepapa ruruku me te hono takotoranga-whenua tēnei nukuhanga, ā, ka wātea a Aotearoa i ēnei kaikonihi mō āke tonu atu.

I whakatūria a Zero Invasive Predators Ltd (ZIP) i te tau 2015 e ūna kaiwhakatū kōtui tuatahi, e Te Papa Atawhai me NEXT Foundation, hei kōkiri whakamua i ngā rangahau me ngā whakawhanaketanga e hiahiatia ai hei haepapa i ngā kaikonihi, me te ārai i a rātou kia kaua ai e whakaeeke anō i aua wāhi. Kua whakatupuria e ZIP tētahi ara whakahaeere urutau hohoro hei whakamātautau i ūna hangarau, e puta ai he auahatanga i runga i te kakama.

Ko tō rātou whāinga he whakawhanake hangarau kia whakatūria wawetia, hangarau auaha, hangarau pakari te tautoko, hei whakakorehāhā rawa i te kiore, i te paihamu me te toriura i ngā rohe nunui o te tuawhenua, me te ārai i te hokinga mai o te kaikonihi ki aua wāhi. Nā tēnei ara mahi kua tutuki tētahi kaupapa i te riu o te Awa o Perth i South Westland, arā, kua whakakorea te paihamu me te toriura i ngā heketea 12,000 o te tuawhenua pāhiwihiwi, nā te hoatu i te tauira 'me haepapa, me ārai', kei roto nei ngā ritenga e whai ake nei:

- > **He pēhi rawa i te hokinga mai anō mā te whakatū tauārai kaikonihi.** Nā ngā rangahau a ZIP (he mea tautoko e OSPRI) i whakaū, ka taea te nekehanga paihamu te ārai e tēnei mea te awa. He rangahau taketake tēnei mō ngā kaupapa haepapa rohe whānui, me te whakamahi tauārai i te taiao hei ārai i te hokinga mai o ngā kaikonihi ki te rohe.
- > **He haepapa rawa i ngā kaikonihi i te wāhi e tiakina ana (i muri i aua tauārai).** E whakamātauria ana anō hoki e ZIP i ēnei rātōna ara '1080 to Zero', e whakamahi nei i te tāoke 1080 (i tēnei wā koinei te taputapu tāmi kaikonihi rohe-whānui e whakamahi nuitia

ana) engari ko āna tikanga mahi he haepapa rawa i ngā kaikonihi i tētahi takiwā. I muri i ngā mahi ā-waka topatopa ka whai i muri ko ngā ara i te whenua tonu, ko te tārore tērā, ko te whakangau tērā, ko ngā puna māunu ā-takiwā tērā. Ko tētahi whakaaro kei muri, kia oti katoa te wāhi te haepapa ūna kaikonihi, e kore tātou e mate kia hoki anō ki te whakataka pūranga rahi o te 1080 i te takiwā o te kaupapa. Ko te whakaaro ka taea te 1080 te whakamahi hei tikanga takitahi hei haepapa rawa i te kaikonihi, me te waiho i tōna whakamahinga auau i muri hei tāmi i aua kaikonihi, he tino whakaaro pai ki ētahi tāngata. I ngā whakamātautau i te takiwā i te riu o Perth River, kua kitea e ZIP ētahi hua mō te haepapa i te paihamu me te toriura mā te whakamahi i tēnei tauira, ā, e ahu whakamua ana hoki te haepapa i ngā kiore whakamutunga kei reira anō hoki

- > **He kite i ngā kaikonihi kei te ora tonu me te haepapa i ēnei kaikonihi i mua i te āhei kia tupu anō te taupori kia hauora.** Kua tutuki hoki i a ZIP ētahi o ana whāinga mō te whakawhanake taputapu pūrongo mamao kia pai ai te urupare wawe ki ngā pokanoatanga mai, kia tiakina rawatia ai ēnei takiwā haepapa kaikonihi. He taurite tonu te hira o te whakaiti rawa i te whakaekenga anō, me te tika o te urupare, ki te whāinga tuatahi o te haepapa i ngā kararehe katoa. He wāhanga tēnei me aro nui tonu te hōtaka Kaikonihi-Kore katoa

E arotahi ana a ZIP ki te rangahau me te whakawhanake, te whakamātautau me te hoatu i ngā taputapu me ngā tikanga hou mō ēnei whakaritenga mahi katoa. He mea hira tā rātou mahi i te takiwā o te riu o Perth River, e mōhio ai tātou he aha ngā ara tika hei haepapa kaikonihi i te tuawhenua, hei ārai hoki i te takiwā kei whakaeeke aŋō.

Te Whāinga: Hei te 2025, kua haepapatia katoatia ngā kaikonihi whāngote i ngā moutere o Aotearoa kāore he tangata.

Te Aromatawai

He matauhua te kanorau koiora o ngā moutere i te moana, ā, hei kāinga ēnei mō te tini o ngā momo māori e kore e kaha ki te noho i te tuawhenua, kei reira te tini o te kaikonihi. Kei ngā moutere o te moana tētahi whāinga wāhi kia whakahaeretia ēnei wāhi – he taupā māori ūnā, ka taea te ārai – i roto i ngā herenga o ngā hangarau o nāianei. Neke atu i te 110 ngā moutere kore-tangata e noho kaikonihi-kore ana i tēnei wā, ā, kei runga rawa atu tō tātou mōhio ki ngā haepapatanga kaikonihi i waenga i ngā whenua o te ao. Ahakoa tērā, e kore e tutuki tēnei whāinga tārewa hei te taenga ki 2025, nā te rahi tonu o ngā moutere i te moana e toe ana, me te wā ka pau i te haepapa rawatanga.

Te Horopaki

Ko Te Papa Atawhai te hinonga mahi mātāmua mō ngā haepapatanga moutere i ngā whenua whāomoomo tūmatanui. I roto i ngā tau kua haere ngā mahi mai i tētahi kaupapa ki tētahi, ā, he ara tēnei i hokia ngā haumitanga ki ngā pūmanawa e tika ana, me ngā takaroaroatanga i te taha. I te tau 2021, i whakatūria e Te Papa Atawhai tōna Tira Haepapa ā-Motu (National Eradication Team) hei whakatika i tēnei āhua, kia whakawāteatia te haere mō tētahi hātepe rōnaki mō ngā pūkenga me ngā rawa, e kakama ai te mahi haepapa. Ka riro mā tēnei tira e whakatū ngā hangaroto hei whakatutuki i tēnei whāinga, kia matawhānui hoki te titiro ki ngā kaupapa moutere katoa.

Tētahi tohu whakaoti taketake o tēnei ko te whāinga wā-waenga o te haepapa poaka, haepapa ngeru, mauhi hoki i Maukahuka (Auckland Island) i te takiwā o Tiritiri o te Moana. Ko Maukahuka te moutere tuarima nei tōna rahi o Aotearoa arā, 46,000 heketea te nui, i Aotearoa, ā, kia huihuia kei te āhua rite tōna rahi ki ērā atu haepapatanga moutere katoa o tau kē. I haumitia e Te Papa Atawhai tētahi \$3 miriona i roto i te 3 tau hei whakaoti i ngā mahi hoahoa mō te haepapatanga poaka, haepapa ngeru, mauhi hoki i Maukahuka (te kaupapa Maukahuka Pest Free Auckland Island). I oti ngā mahi hoahoa i te tau 2020, me tana tāpae pūrongo tērā e haere te mahi haepapa mō tōna 10 tau. Kua oti noa atu te nuinga o ngā whakamahere mahi me ngā matapae utu, nā reira kua rite te kaupapa kia whakatinanatia, kia wātea mai he pūtea, he tautoko hoki hei timata i te mahi.

Tērā anō ngā mahi i mahia mō ngā tau e rima ka hipa ake nei hei tautoko i tēnei whāinga, tae atu ki ēnei:

- > I whakaūngia te haepapatanga o ngā mauhi i te Moutere Mahue (Antipodes Island) i te takiwā o Tiritiri o te Moana (2100 heketea) i te tau 2018. I mahi tahi Te Papa Atawhai me ngā kaitautoko tūmatanui, te Morgan Foundation, WWFNZ, me Island Conservation ki te hora i te kaupapa ‘Million Dollar Mouse’ i te tau 2016, me te tautoko mai a te tini.
- > Kua tutuki te haepapatanga o te mauhi i Motuareronui (Adele Island) (2017) me Te Hoiere (Maud Island) (2019) e Te Papa Atawhai.
- > Te urupare a Te Papa Atawhai ki ngā whakakenga mai o ngā kīrearea ki ngā moutere he kaikonihi-kore i tēnei wā. Kua uru mai hoki te Kaunihera o Tāmaki Makaurau, nā tana hāpainga i te whakaū tūnga kaikonihi-kore i muri i te haepapatanga, mā ngā mahi haumaru koiora i Tikapa Moana (Hauraki Gulf) me te tautoko i ngā urupare ki ngā whakaekenga.

Atu i tēnei rā me haere ki hea

Ka kitea i roto i ngā tūhuratanga haepapatanga me te ekenga taumata kaupapa tae mai ki tēnei wā he pēhea e puta ai he hua i ngā ahunga whakamua o te whakamahere, me te hangarau i roto i ngā haepapatanga e piki tonu nei te matatini, o ngā kaikonihi whāngote whakaekē. Ahakoa tērā, hei te pikinga ake o te matatini me te rahi, ka piki anō hoki ngā mōreareatanga (ā-pūtea, ā-rauropi, ā-ingoa tangata). I haumi ngā mahi hoahoa hōhonu me te rangahau whakamahere mō te kaupapa Maukahuka i tētahi ara nā ngā taunakitanga i tautoko, me te whakatika i ngā rangiruatanga mā te whakamātautau ā-rahi i ngā tikanga mahi. Nā konei i puta ai he māramatanga mō ngā kaiwhiriwhiri whakatau, mō te rahi me ngā uauatanga o ngā mahi, i puta ai he tauira tikanga mahi pai rawa mō ngā haepapatanga o raurangi.

I te tau 2021, ka tautuhi anō te Tira Haepapa ā-Motu a Te Papa Atawhai (National Eradication Team) i te aronga o tēnei whāinga tārewa, me te tautohu ko ēhea ngā moutere e taea ai, e whai hua ai, te mahi kia kaikonihi-kore. Ka hanga mahere rerekē hoki te tira hei whakatutuki i te kaupapa nui o te whāinga, i runga anō i ētahi wātaka hou mō te haumi. Ka aro hoki ēnei mahere ngā mahi hou i te ao hangarau haepapa, e whakawhānuitia ai ngā ara whakapai i te hātepe.

Te Whāinga: Hei te 2025, kua oti tētahi putanga pūtaiao turaki maioro te whakawhanake e taea ai te haepapatanga o tētahi whāngote kaikonihi nonohi i te tuawhenua o Aotearoa.

Te Aromatawai

Kāore anō kia puta tētahi rongoā pūtaiao turaki maioro kotahi kīa ai e te tangata kua tutuki tēnei whāinga, ā, nā te uaua tonu o tēnei mea te rangahau pūtaiao tērā ngā uauatanga anō o te ine ahunga whakamua i te taha o tētahi whāinga e karanga ana kia kitea he 'rongoā pūtaiao turaki maioro' i mua i tētahi rā motuhake. Nā reira, ka waiho tēnei wāhangā i te aromatawai i te tūponotanga o te whakatutuki tēnei whāinga i mua i te tau 2025, ka huri kē ki te tātaki i ētahi o ngā ahunga whakamua o te mahi pūtaiao e pā ana ki Kaikonihi-Kore i roto i ngā tau e 5 ka hipa ake nei.

Te Horopaki

I te kawe kē a Manaaki Whenua me te Biological Heritage National Science Challenge (BHNSC) i ētahi rangahau mō te whakahaere kīrearea, engari mai i te whakarewanga o Kaikonihi-Kore 2050 kua whakakahangia e rātou tēnei tirohanga ki te uaki mahi hou hei tūhuratanga.

E whakawhanaketia ana e Manaaki Whenua ētahi tāoke aro-momo kotahi, ka noho hei mea taketake mō te haepapatanga i ngā rohe whānui mahi pāmu. Kua tīmatatia e Manaaki Whenua tētahi hōtaka rangahau 5-tau i te tau 2019 e mōhiotia nei ko 'Eradication Science: Eliminating the last survivors to achieve predator freedom' e tautokona nei e te Endeavour Fund o Hikina Whakatutuki. E tūhura ana te hōtaka i te whakawhanaketanga o ngā taputapu hou, i runga anō i ngā whanonga kaikonihi, e piki ake ai ngā mahi haepapa mā te whakaū tikanga e mau ai ngā kaikonihi takitahi whakamutunga o tētahi wāhi te tārore.

E āwhina ana a BHNSC i te taha ki ngā rongoā tami, haepapa rānei i tētahi kīrearea kotahi, neke atu rānei, i te tuawhenua o Aotearoa New Zealand. Kua haumitia kētia e BHNSC neke atu i te \$1.5 miriona ki ngā rangahau Kaikonihi-kore, ā, e noho tonu ana hei hoa kōtui tūturu mō te kaupapa Kaikonihi-kore 2050 mā āna mahi i raro i Tranche 2. Ko ētahi o ngā mahi a BHNSC he rangahau pāpori (te pae matatika koiora me ngā waiaro tūmatanui ki ngā hangarau ārai kīrearea hou), he mahi pūtaio hoki e whakatinanatia ana, tae atu ki te whakawhanaketanga o tētahi tāoke aro ki te kiore, mauhi rānei, he rangahau i ngā hangarau hou hei haepapa kaikonihi, te whakamahinga tino whai hua o ngā taputapu/tāoke, te whakawhanaketanga o tētahi hangarau kāmera AI hei tautohu i ngā kīrearea whāngote, nā ZIP i whāngai tahi ki te pūtea.

Nā te whāinga o Kaikonihi-kore 2050 kua ara ake ētahi whakahaere hou, hōtaka hou e āwhinatia ai te auahatanga me te rangahau. E ai ki ngā whakamārama i te whārangī whārangī 39, kua noho a ZIP hei kaihautū i te auahatanga taputapu, tikanga mahi hoki mō te haepapa kaikonihi.

Ko te whāinga o te hōtaka a Te Papa Atawhai e kī nei ko Tools to Market, kia wātea he taputapu, he hangarau atamai kē atu ki te hapori Kaikonihi-kore 2050 i roto i te 1–5 tau. E whakawhanaketia ana te hua tuatahi (he poapoa kiore e kore e waimeha) e Wellington UniVentures, hei hoko ki te ao. I oti ngā hurihangā whāngai pūtea i Tools to Market i ngā tau 2017 me 2019, ā, i tēnei wā e ono ngā kaupapa e mahia ana, he poapoa ētahi, he toromāhangā, he tāoke, he matatopa hei tuku māunu ētahi. Kua tukua kētia e Te Papa Atawhai tata ki te \$7miriona ki tēnei kaupapa, ā e mahi kōtui ana me Predator Free 2050 Limited ki te ruruku, kia tino whai painga ai ā rātou haumi tahitanga ki ngā hangarau ārai kaikonihi.

I aro nui te rautaki rangahau 2017–2020 a Predator Free 2050 Limited ki tēnei whāinga. I haumitia e te kamupene tētahi \$1 miriona ia tau ki ngā mahi rangahau, i puta ai:

- > Te whakaputanga o ētahi huinga ira (genomes) tuatahi o te ao, ka taea te whakaingoa i te ao pūtaiao, mō te kiore piki taura me te toriura.
- > E whakawhitia nei tētahi paerewa hoahoa tahi mō te tārore kaikonihi me ngā raraunga puna māunu kia whakamahia i te ao mahi. He ritenga taketake tēnei e taea ai te tohatoha me te tātari i te tini o te raraunga.
- > He taunakitanga ka taea e ngā kāmera kite-mahana/AI te whakapiki i ngā kitenga kaikonihi mā te 5–50X, me te wātea o tēnei hangarau hei whakamahinga i ngā kaupapa rohe whānui.

Hei waitohu ngā rangahau huinga ira i te ahunga whakamua o tā tātou e mōhio ana mō te koiora o ēnei kararehe, ā, koia tērā te kahupapa mō ngā ara rangahau o raurangi, e tutuki ai pea tēnei whāinga.

He mea whāngai te kōkiri Products to Projects e te Provincial Growth Fund, he mea whakahaere hoki e Predator Free 2050 Limited, kua toha nei i te \$6.5 miriona neke atu hei whakahohoro i ngā mahi rangahau, whakawhanake, whakanao hoki i ngā taputapu me ngā hangarau ārai, haepapa hoki i ngā kaikonihi. Tekau mā rima ngā hua kua whāngai ki te pūtea puta noa i ngā momo hangarau huhua, he poapoa ētahi, he taputapu pūrongo, whakahaere ētahi, he hangarau kāmera ētahi, he whakamahi tāoke, he tāpiko toromāhangā anō ētahi. E whā anō ngā hua e wātea ana ināianei hei hoko. I whakarewaina tētahi hurihangā whāngai pūtea tuarua i 2021 mā roto i Jobs for Nature.

Atu i tēnei rā me haere ki hea

He mea taketake kia whakawhanake haere tonu ngā whakahaere maha i te ao pūtaiao, whakawhanaketanga hoki i ētahi ara ruruku mō te mahi tahi, e tino whai hua ai ngā pūtea e wātea ana mō te rangahau me te whakawhanaketanga. He mea hira te wāhi ki te rōpū pāhekoheko e mōhiotia nei Advancing our knowledge, innovation and improvement i tēnei taha. Mā tā rātou mahere 5-tau ka mārama kē atu te utu tūturu o te haumi i ngā mahi rangahau, hangarau hoki hei tautohu i ngā kōkiri wāwāhi taiepa, turaki maioro hoki hei whakarewa i ngā mahi haepapa rohe whānui.

I runga anō i te mahi tahi ki BHNSC me ngā ahunga whakamua o ēnei tau, kua whakawhanaketia e Predator Free 2050 Limited tētahi rautaki rangahau hou mō 2021–2024 hei ārahi i te haumitanga pūtaiao o \$3.5 miriona ia tau. E arotahi ana tēnei ki ngā mahi turaki maioro e tutuki ai te haepapatanga i ngā rohe whānui kē atu, te wewete i ngā taumahinga huinga ira kaikonihi, me te whakawhanake i te raukahā i ngā pūtaiao, tae atu ki te mātauranga Māori. Kua puaki mai a BHNSC e tautoko ana rātou i te Kaikonihi Kore Aotearoa 2050 i tō rātou rautaki Wehenga Tahu 2, me tō rātou aro ki ngā taputapu tāmi kīrearea: tētahi ara kite rarunga i tawhiti mō te whakamahi i te atamai hangahanga hei tautoko i te kitenga rohe whānui me te korehāhā whāngote whakaeke (ko te utu kei raro i te \$10 mō te heketea kotahi) me tētahi taputapu mātauranga Māori mō te tāmi, te haepapa rānei i ngā kīrearea whāngote whakaeke.

Te āhua nei e kore e puta tētahi 'rongoā pūtaiao turaki maioro' i ngā rangahau ka haere ākuanei, engari ka tutuki pea tēnei whāinga hei raurangi, mā tētahi kāpuinga taputapu hou, tikanga mahi hou hoki.

Te Whāinga: Hei te 2025, kua tautuhitia e ngā whānau, ngā hapū me ngā iwi ngā wāhi matua mō te ārai me te haepapa kaikonihi. Tāpiri atu, e rima kaupapa haepapa e arahina ana e te whānau, e te hapū, me te iwi kua horaina ki te motu whānui.

Te Aromatawai

I tēnei wā kotahi te kaupapa haepapa kaikonihi e haere ana, e mahi ana i tēnei wā, ko Korehāhā Whakahau, i raro i a Ngāti Awa. Meāke ka tīmata tētahi kaupapa i Te Urewera, i raro i a Ngāi Tūhoe. Ahakoa tērā he mea nui kia kaua e noho ko tēnei whāinga anake te wawata katoa mō te whāinga wāhangā mai o ngā whānau, o ngā hapū me ngā iwi i roto i ngā rautaki, ngā kaupapa me ngā rangahau o Kaikonihi-kore 2050. He kōkiri kotahi tēnei i raro i tētahi huinga huaputa whānui kē atu, e matapaetia nei i te ara ‘Mā nga whānau, mā ngā hapū, mā ngā iwi e whakatau tō rātou kaitiakitanga’ o te Rautaki Kaikonihi-Kore.

Te Horopaki

I waihangatia a Korehāhā Whakahau e Te Rūnanga o Ngāti Awa (tētahi hinonga whakahaere i ngā whakataunga i whakaaetia kia noho hei kanohi mō ngā hapū 22 o Ngāti Awa), ā, i whakarewaina i te tau 2020. I tautokona tēnei kaupapa e Predator Free 2050 Limited, e Kaimahi for Nature (Te Papa Atawhai) hoki, ā, ko Korehāhā Whakahau te kaupapa Kaikonihi-Kore tuatahi kia aratakina e tētahi iwi Māori. Ko tāna he haepapa i ngā paihamu katoa i ētahi whenua 4600 heketea te rahi i roto i te rohe o Ngāti Awa i roto i te 5 tau, kia āwhinatia hoki te tiaki me te whakareinga o te taiao.

Kua tīmata kē te mahi tiaki a ngā hapū o Ngāti Awa i tō rātou whenua hei 'kaitiaki nō muri mai anō'; he whakaūnga noa iho tēnei o taua mahi, engari mā konei ka whiwhi mahi ngā uri o Ngāti Awa, kia kawea te kaupapa e rātou. Hei āwhina tēnei kaupapa i ngā pūmanawa me ngā pūkenga o Ngāti Awa hei kaitiaki, ina hoki, 16 ngā tūranga mahi mō tētahi tira kaimahi pakari ka ako i ngā pūkenga ka taea te kawe ki mahi kē, hei tautoko i ō rātou whānau, hei tautoko hoki i te kaitiakitanga o ngā hapū o Ngāti Awa i ēnei rā, ā, haere ake nei.

He kaupapa mīharo a Korehāhā Whakahau, e whakamahi tahi ai tētahi kaupapa i raro i te iwi i te mātauranga Māori me te pūtaiao o te ao hou hei hanga huaputa takatika mō te taiao. I roto i ngā kaupapa i raro i ngā iwi ka kitea te wāhi nui ki a ngāi Māori i roto i te ahunga ki tētahi Ao Kaikonihi-Kore mō Aotearoa New Zealand, ā, hei whakatauritetanga ēnei ki ētahi atu kaupapa kei roto te mana whenua i ngā kaupapa e arahina ana e ētahi atu.

I te marama o Paenga-Whāwhā 2021, nā Predator Free 2050 Limited i whakapuaki tā rātou whāngaitanga moni mō te kaupapa i raro i a Tūhoe mō te haepapatanga o ngā moutere me ngā kūrae huri noa i Waikaremoana, me te whakawhanaketanga o ētahi tūranga mahi toitū 10.

E kitea nuitia ana ngā mahi kōtui a ētahi kaupapa ehara i raro i te iwi kia uru mai te mana whenua ki ā rātou kaupapa, engari kāore ngā mahi tautohu wāhi mahi, mahi hoahoa rānei i te kawea e te whānau, e te hapū, e te iwi rānei i te tīmatanga.

Atu i tēnei rā me haere ki hea

E anga ana te titiro a te whānau, a te hapū, a te iwi hoki ki ētahi kaupapa Kaikonihi-Kore hei hanga whāinga wāhi whiwhinga mahi mā te rangatahi i te kāinga, i wāhi kē, hei hora hoki i ngā mahi whakangungu e taea ai. Mā te whakarewa i ētahi atu kaupapa mā te iwi e hautū e piki ake ai pe a ngā whāinga wāhi whakangungu, whiwhinga mahi mā te rangatahi i tō rātou rohe, e tutuki ai tēnei whāinga tārewa hei te tau 2025.

Mā ngā wheako o te kaupapa Korehāhā Whakahau e tāreia ai he tikanga rangahau i raro i te maru o te iwi hei haepapa kaikonihi. Mā konei hoki pe a e taea ai e Ngāti Awa te tiri i aua akoranga ki ētahi atu iwi, ki te hapori, me te hunga pupuru whenua whai wāhi ki ngā kaupapa haepapa kaikonihi rohe-whānui.

Ka puta hoki he akoranga mā ngā kaupapa ehara i ngā iwi, he pakari te hononga ki te mana whenua, ka taea hoki te tautohu tikanga mā rātou e whakareia ai ā rātou kaupapa, mā te mahi tahi me te mana whenua ki te whakatutuki i ngā whāinga o te katoa.

He mātai tūāhua:

Mai i te Āhua Hē ki te Kōtuitanga Tiriti Whai Hua

E whakaae ana te kōtuinga Tiriti i te kawenga mātāmua a te whānau, te hapū me te iwi i roto i te ahunga o te kaupapa kia Aotearoa Kaikonihi-Kore, mō te hoahoa, mō te whakatau, me te hora kaupapa whakahaere kaikonihi, ā, he kawenga matua tōna i ngā pāhekohekotanga ā-motu, ā-takiwā whānui anō hoki.

I timata te Kaupapa o Taranaki Mounga (TMP) i te tau 2016. Ko tōna whāinga he whakapūmau i te noho ora o te maunga, ūna pae maunga i te taha, me ngā moutere o Taranaki i ngā kīrearea, he whakaora, he whakaoho anō i te mauri o ngā koiora me te whakapiki i te toitū o te pūnaha hauropi. Me mahi tonu kia pai ake te whanaungatanga o te kaupapa ki ngā iwi o Taranaki, heoi anō, ko tōna tīmatanga ko te whai wāhi i te tīmatanga. E pūrongo ana a Taranaki Mounga me te Taranaki Iwi Chairs Forum ka noho ko ngā āhuatanga e whai ake nei hei mea taketake mō tō rātou hononga. Tā tēnei mātainga he tango i ētahi o ngā hātepe me ngā mahi o raro i TMP ka taea pea te whakahāngai ki ētahi atu kaupapa puta noa i Aotearoa New Zealand.

Te Anga Kaupapa: Kei roto i te hanganga o te poari tētahi tūranga mō te Taranaki Iwi Chair Forum, e noho ai he māngai mana whenua, i te taha o tētahi tūranga heamana motuhake, me tētahi māngai mō NEXT Foundation. Kua noho mai hoki he kanohi pakari i ngā taumata mahi anō hoki (kia mōhio, kaua tēnei hei whakakapi i te tuitui ki te mana whenua). He whakaatatanga noa tēnei o te whakaae a te kaupapa he mea taketake kia mārama ki te wāhi, ki ūna tangata hoki, e tutuki ai ō rātou whāinga.

Te whai wāhi ki te whiriwhiri take: E kawea tahitia ana ngā mahi whakatau take i ngā taumata katoa o te kaupapa. Mai i te hātepe rautaki ā-tau ki ngā whakatau mō ngā mahi, kei te whakatau take te tangata whenua, kāore e torongia noatia ngā whakaaro mō aua whakatau.

Te whakahāngai i ngā whāinga kaupapa ki ngā whāinga o te mana whenua: Nō te hanganga me te arotakenga a TMP i tāna rautaki kaupapa, i mātaia e rātou ngā whāinga rautaki nā te mana whenua i tautuhī, i hoahoa hoki rātou i tā rātou kaupapa hei hora putanga e tautokona ai ngā rautaki a te iwi i ēnei rā. He hōhonu tonu te tirohangā a te iwi ki te hapori me ūna hononga, e ngāwari ai te whakaaetanga pāpori hei whakapiki i ngā huaputa kanorau koiora.

He hononga i runga i ngā uara: Ka whāia e TMP he ara pono kia aratakina e ngā whakaaro me ngā anga tikanga o te ao Māori. Ka riro mā ngā uara Māori hei arataki ngā mea katoa, mai i ngā anga rautaki ki ngā whakatau i te taha whakahaere – koia ēnā te ‘he aha ai’ mō TMP. E noho ana te whanaungatanga hei uho mō te kaupapa, he kaupapa e whakatupu nei, e atawhai nei i ngā hononga o te tangata ki tētahi wāhi, ki a rātou tonu anō i roto i mua, i tēnei wā, āpōpō hoki – ko te whanaungatanga hei hora putanga tētahi poutokomanawa mō te kaupapa.

Ngā putanga pāpori: Ka heipū ngā mahi a TMP ki ngā putanga pāpori, taiao anō hoki mā roto i tana mahi whakaora i te mounga, i runga i te whakaaro o te ao Māori, he mea paihere mārire te hauora o te tangata me te whenua. Tērā tētahi kōkiri o ēnei marama tata i pōwhiritia ai ngā taitama hoki ki te hara kia mahi i TMP, ā, i kitea ētahi hua papai mō te kaupapa me te rangatahi.

Te hanga tūranga mahi: I te tuatahi i tukua ngā mahi ake ki Te Papa Atawhai, engari kua timata ināianei tētahi kaupapa wā roa hei hanga raukahā i roto i te rohe, hei hora whāinga wāhi hoki mō te whiwhinga mahi ki te rangatahi. E whakahāngaitia ana ngā whāinga wāhi mō te whiwhinga mahi me te whakangungu ki ngā pūkenga i roto i te iwi ināianei, ā, he mea āta hoahoa kia noho tētahi ara mā te rangatahi hei whakawhanake i ēnei āhuatanga ki tua rawa i ngā tūranga taumata tuatahi, kia uru ki ngā tūranga hangarau, whakahaere kaupapa hoki.

Te whai wāhi o te tangata: E mahi ana a TMP i runga tonu i ōna uara i āta hoahoa kia puta he hononga pakari kia hangaia hoki he ahurea tira e whai wāhi ai te katoa. Ko ērā uara ko te mana motuhake, ko te tirohangaroa, ko te manaakitanga, ko te kotahitanga, tētahi atu ko 'kia tika kia pono;' te tikanga o tērā kia whakaumu, kia kakama, kia whai take ngā mahi.

E ngana a TMP ki te whakaheke i ngā maioro e ārai nei i te tangata e Kore ai e whai wāhi ki ngā kōkiri tiaki taiao. Ka taea e te tangata te āwhina i te kaupapa i ngā taumata katoa, mā te whakanui i ngā mahi a te hunga ka puta mai ki te āwhina mō te rā kotahi, me ā te hunga tae pūputu mai anō hoki.

He tino kūrae okiokinga te whakaurunga mai o ngā iwi i ngā taumata katoa, nā konei i ngāwari ake ai te uru mai o ngā mana ā-rohe; me i kore te iwi, kua kore e pērā. He mea hira te tūnga o TMP hei 'takawaenga pono', e tū motuhake nei i waho i ngā mana nunui tētahi mea nui mō te whakapakari i te whakapono a tētahi ki tētahi, te whakatūtika i te korenga e ōrite o te mana, me te hāpai i te mana o ngā tāngata me ngā rōpū whai pānga katoa.

Te Aromatawai

Kua tino pakari haere ngā rōpū tārore i ngā tāone nui puta noa i te motu, i ngā tau e 5 ka hipa ake nei. I tēnei wā ko ngā rōpū o Predator Free Wellington me Capital Kiwi ngā rōpū i tino ahu whakamua ki tēnei whāinga, me te aha, ka tutuki pea te haepapatanga o ngā paihamu me te whānau tori i Te Whanga-nui-a-Tara i 2025. Tērā anō ngā pīkauranga nui kei mua – ko te ārai i ngā ahunga whakamua kia kore ai e memeha, me te kawe whānui i te kaupapa ki te tāone katoa, tētahi mahi uaua. E hohoro haere ana ngā mahi Predator Free i Tāmakimakaurau me Ōtepoti, ā, e puta ana anō hoki he hua pai. Me kōrero rā te wāhi nui ki te kaha o te hapori e tutuki ai te kaupapa, ina hoki, me mātua tautoko te nuinga o ngā tāngata o tētahi tāone, kia tutuki ai tētahi haepapa ā-tāone nui.

Te Horopaki

Ko te whāinga ia o Capital Kiwi he whakahoki mai i tētahi taupori kiwi mohoao i ngā hiwi me ngā riu tonu o Te Whanga-nui-a-Tara. Kua whakatūria tētahi whatunga tārore hei patu toriura puta noa i te kūrae nui tonu o Te Whānga-nui-a-Tara, (23,000 heketea te rahi) ā, e aroturukingia ana e ngā rōpū kaunihera, hapori hoki. Waihoki, kua whakatūria e Predator Free Wellington tōna takiwā 30,000 heketea te rahi, kua oti te wehewehe ki ngā wāhanga e rima. I tutuki pai te haepapatanga o ngā paihamu, o ngā toriura me ngā kiore parauri i Te Motu Kairangi/Miramar Peninsula, tētahi takiwā 800 heketea te rahi, ā, kua tauāraia ēnei wāhi mō te nuinga o ngā marama o tētahi tau kotahi. E whakaaarotia ana e wātea ana te kūrae whānui, tōna 90% nei, i te kiore piki taura. Mai i te tīmatanga, i hiahia a Predator Free Wellington i te tautoko o te 100% tāngata kei Te Motu Kairangi/ Miramar Peninsula e noho ana, kia āhei ai ia ki te whakatū puna māunu i ngā wāwāhanga īhua 50 m x 50 m te rahi, me nga tārore i ngā wāwāhanga īhua 100 m x 100 m puta noa i te kūrae katoa. Neke atu i te 3000 ngā whakaaetanga i hoatu ki ngā mema tira o Predator Free Wellington kia tomo ki ngā whare me ngā umanga, kia mahi tahi hoki me ērā atu kaipupuru pānga ki te whakatinana me te whakatika i te wāwāhanga haepapa i roto i te 6 marama.

Kāti, kia tahuri ki Tāmakimakaurau. I raro i te Mahere Whakahaere Kirearea ā-Rohe, he mea whāngai i tētahi pāpātanga i aronuitia, kei te whakarahia ake te tāmitanga paihamu kia eke ki te taumata e kitea ai kua eke te 50% o ngā whenua tuawhenua pāmu o Tāmakimakau rau (179,000 heketea) i roto i ngā tau e rima e tū mai nei. E ai ki te Kaunihera he kaupapa tēnei ka noho hei takahanga waewae e tutuki ai ētahi kūrae kore-paihamu i te rohe.

Kua tīmata te kaupapa City Sanctuary o Predator Free Dunedin, mā ētahi takiwā noho whakamātautau e toru hei kōkiri i te kaupapa, kia mārama hoki ki ngā tino huarahi hei tuitui, hei tautoko, hei pāhekoheko hoki i ngā hapori e tutuki ai te haepapa kaikonihi puta noa i te tāone katoa. E tautoko ana Predator Free Dunedin i ngā pūtea me ngā tautoko mō ngā kainoho me ngā rōpū hapori kia tīmata ngā mahi tārore, kia aroturuki huaputa hoki. Ko te whāinga wa roa mō te kaupapa City Sanctuary he whakatō i te kaupapa ki ngā whenua 8,000 heketea o ngā takiwā noho, me te whenua whānui o te tāone.

Atu i tēnei rā me haere ki hea

I te wā e whakatūria ana, e puta mai ana ngā kaupapa tāone, ka riro mā aua wheako hei ārahi ngā tino tikanga mahi, me te wāhanga me rangahau haere tonu, tae atu ki ngā whāinga tuituinga pāpori e hiahiatia ana mō ngā rohe whānui o ngā tāone.

I mua atu i te kaupapa ‘Predator Free Wellington’, i haere tōna matua, ko ‘Predator Free Miramar’, ā, tērā hoki ētahi atu rōpū tārore ā-tāone i whakahaeretia e ngā tāngata o te takiwā i kaingākau kia tū mai he tāone e noho tahi nei te tangata me te taiao, me te noho mai o ētahi momo mōrearea i te taha. E tino tautoko ana te hunga o Te Whanga-nui-a-Tara kia hauora ngā koiora o reira, ina hoki, e rua hautoru o ngā tāngata i pūrongo mai i tētahi uiuinga nā te Kaunihera o Te Whāngā-nui-a-Tara kei te whai wāhi ki ngā mahi Kaikonihi-Kore, kei te hiahia rānei kia uru atu, ā, he rōpū tārore kei ia takiwā noho.

I āta whakarite tikanga a Predator Free Wellington kia whakapātaritia te kaingākau i te hapori, ahakoa te whakaumutanga o te kaupapa ki tētahi wāhangā mahi mātanga nei, he huhua ūna kaimahi e utua ana, me te whāngaitanga mai i ngā pūtea o waho. E rua ngā aronga o te rautaki. Ko te tuatahi kia whakapā atu ki ngā rōpū hapori ki te tono mehemea e hiahia ana rātou kia whai wāhi ki te matakite o Predator Free Wellington, tuarua, mehemea āe – me pēhea te tautoko a Predator Free Wellington i a rātou. Tuarua, me whakamahi ētahi kaimahi i te taiao e utua ana mō ngā mahi haepapa i āta whakahāngaitia, i roto i ngā rohe i āta tautuhitia

Nā Predator Free Miramar i para te huarahi mō ngā tutukitanga haepapa i te kūrae, i roto i āna wāhi mahi maha:

- > Nā te whatunga tūao i reira mai rā anō, he iti iho ngā kiore me ngā kaikonihi i reira hei patunga, mai i te tīmatanga. I kitea i roto i ngā mahere mahana-tinana, tērā tētahi hāngaitanga poka tika mai i ngā āputa o te whatunga tārore tūao, ki ngā wāhi wera he kaha ake te kai māunu.
- > Kua tino mōhio kē te hapori ki ngā painga o ngā mahi Kaikonihi-Kore nei, ā, nā ngā mema o te hapori i kawe te rongopai mō Predator Free Wellington ki ō rātou hononga, whatunga hoki.
- > Nā ngā kaitārore tūao i whakahaere ngā mahi i te pito whakateraki o te kūrae. Ko ētahi o ēnā mahi he tirotiro, he whakatakoto māunu, he pūrongo, he aroturuki, i wātea ai ngā kaimahi e utua ana kia arotahi ki ngā takiwā tāone.
- > He mea taketake te tautoko mai a te hapori ina whakaarotia he rautaki putanga mō tētahi kaupapa haepapa. E 20,000 ngā tāngata whai kanohi ināianei e tirotiro ana ki te kūrae, tērā pea ka kitea e rātou tētahi paihamu, toriura rānei, me te pūrongo i tērā ki te tira kaupapa.

Tā Predator Free Wellington he whakakite ki te ao me pēhea ngā kaupapa rahi e tō mai ai i te iwi, e akiaki ai i te whanonga tangata hei tautoko i ngā koiora hauora. Ko te tautoko ā-haporī kei te manawa o tēnei kaupapa, ā, he mea taketake mō te ekenga taumata. Ka aro tēnei kaupapa ki ngā huaputa pāpori, ōhangā hoki mō te tāone me ūna tāngata. Ko ētahi o ngā akoranga mai i te Wāhanga 1 o te kaupapa he pēnei:

- > Kāore e taea te kī kotahi te ara ka whāia mō ngā tuituinga katoa. Ka tōia mai ētahi tāngata mō ngā painga kanorau koiora, engari tērā anō ētahi ka hiahia ki te haepapa kirearea nā te mea, he pōrearea rātou, he tūkino whare, tūkino aha.
- > He tino taonga te pāhopori hei tūhonohono i te tangata, hei tohatoha pūrākau, wheako hoki i roto i te kaupapa.
- > He tino tikanga pai ngā ariā pēnei i te noho 'hei tāone kaikōnīhi-kore tuatahi rawa o te ao' hei whakaihīhi i ngā kaihoe.
- > He mea taketake te whakamahere me te āta takatū i mua i ngā mahi, kia tino rata mai te iwi ki ngā tāoke me ngā tārore, me te mōhio he haumaru. Me mātua whakapono te iwi, e pai ai te haepapa kaikōnīhi, me te kī taurangi, kotahi te mahinga, kua oti i runga i te tika.

Ka noho ko te huinga o ēnei hōtaka rohe whānui, e whakakapi nei i ngā rohe pāmu rarahi, me te whakatūranga o te hōtaka rangahau i te wāhi mahi, e mōhiotia nei ko Farms as Barriers hei tohu kua tū ā-tutuki tēnei whainga mō te tau 2025.

Background

Ko ngā kaikonihi nō tāwāhi tētahi kaikawe kino mō te kawekawe mate ki ngā koiora o te rāngai ahumatua o Aotearoa. Hei kaupare i ēnei mōreareatanga, hei urupare hoki ki ngā kitenga o te māuiui, ka whakapaua tōna \$69m ia tau mō ngā hōtaka TBfree. He mārama tonu te pūtake ūhangā mō te haepapa kaikonihi mō te rāngai ahumatua. Mā te haepapa kaikonihi i ngā whenua tautiaki e tāmi ngā taupori kirearea ka noho hei kaikawe mō te mate kohi o te kau (TB), tērā pea ka reia e rātou te whenua pāmu. He maha ngā hōtaka TB free ka anga ki te tahitahi i ngā tapa ngahere, he mahi tēnei e puta ai ētahi hua tautiaki taiao.

E tutuki ai tēnei whāinga, he mātua whai taputapu, rautaki hoki ngā tāngata o Aotearoa, hei haepapa i ngā kaikonihi i ngā whenua pāmu tūmataiti. Tērā ētahi kaupapa, kōkiri rangahau hoki e whai pitomata nei mō ēnei mahi.

Ko Whakatipu Māhia tētahi kaupapa i roto i te toru o ngā kaupapa tōpū e mōhiotia nei ko Predator Free Hawkes Bay, ā, ki te titiro atu ka oti katoa ngā mahi haepapa paihamu i te kūrae o Māhia, 14,500 heketea te rahi hei te marama o Pipiri 2022. Kua tukua e Whakatipu Māhia he tūranga mahi ki ngā tāngata o te kāinga kia whakaritea ētahi puna māunu, neke atu i te 6500 te maha, puta noa i ētahi heketea 11,000, ā, he pakari te tautoko mai o te hapori. Ko te Banks Peninsula Conservation Trust tētahi tauira mō te waiho mā te iwi o te takiwā e whakaputa kōrero mō ō rātou wāhi. I tīmataria i te tau 2001. Kua roa hoki ngā mahi kōkiri taiao a ngā hapori i Horomaka Banks Peninsula, hei tauira ko te Wildside Project. I haere tēnei i raro i tētahi kōtuinga ki Environment Canterbury, ki Te Papa Atawhai, me te Kaunihera o Ōtautahi, koia hoki pea te kaupapa tāmi kaikōnīhi nā te kaipupuru whenua i ārahi roa rawa i te motu katoa. I whakarewaina 30 tau ki mua, i muri i te kitenga o ngā kaipupuru whenua kua heke te maha o ngā kororā.

Ko te kaupapa rohe whānui o Pest Free Banks Peninsula tētahi hōtaka nā te hapori i tīmata, ā, i kōwhiria te Tarahiti hei kaihautū mō te hōtaka, nā tōna mana hei rūnanga whakaū tikanga, ūna hononga ki ngā kaiahuwhenua me ngā kaipupuru whenua tūmataiti, waihoki ūna tūranga kauwhau tikanga, me tōna āhei ki te tuitui i ngā kōkiri hapori puta noa i te kūrae.

Kua whai Pukapuka Whakaaetanga a Pest Free Banks Peninsula/Te Pātaka o Rākaihautū, nā ētahi hoa kōtui 14 i waitohu, tae atu ki te mana whenua o te rohe. Kua tuia mai hoki ngā mātāpono o Ngāi Tahu ki roto i te rautaki mō te kaupapa – ko tētahi o aua mātāpono, ko ‘mā te hapori e hautū’. Ko ētahi huarahi e kitea ai te ārahitanga ā-hapori i roto i te kaupapa Pest Free Banks Peninsula, ko te aronga ki te whakawhiwhi mahi ki ngā tāngata o te takiwā hei kaimahi, me te tuituinga ki te kamupene hangarau o te takiwā, The Cacophany Project, e whakamātautau nei i ētahi hangarau hou me ngā tāngata o te takiwā e whai wāhi nei ki ngā whakamātautau.

Ko Kaikonihi-Kore 2050 me te ao Māori

He whāinga wāhi a Kaikonihi-Kore 2050 kia whakapakaritia te kōtuitanga i waenga i a ngāi Māori me te Kāwanatanga, mā te pāhekoheko ki tētahi whāinga kawe tahi. Ka āhei ngā hinonga Kāwanatanga te whakaahua, te whakatinana hoki i ngā mātāpono o Te Tiriti o Waitangi, mā te mahi tahi ki ngā whānau, ki ngā hapū me ngā iwi kia tiakina ngā momo e kīa nei he taonga, ki te whakahihiko anō i te hononga tangata ki te aotūroa.

I whakaae te Rautaki Kaikonihi-kore 2050 "He whenu hira ngā uara, ngā tikanga me ngā pūrākau Māori ki te kaupapa Kaikonihi-Kore. Ka mutu, he hira te mātauranga Māori me te hihiri ki te angitutanga o tētahi moemoeā kāore kau ūna takahanga i te ao.... Ka tū mana Māori motuhake ngā iwi, ka whaimana hoki a Kaikonihi-Kore 2050, ina koa tēnei mea te kaitiakitanga, he taute whenua, he taute tangata". He ōrite ngā whāinga o Te Mana o te Taiao – Aotearoa New Zealand Biodiversity Strategy, nā reira kua puta he whāinga wāhi kia mahi tahi ngā rautaki e rua i konei.

Ahakoa kua puta ētahi mahi whai hua tae mai ki tēnei wā, pēnei i te whakatūranga o tētahi rōpū pāhekoheko motuhake e kīa nei 'Whānau, hapū and iwi expressing kaitiakitanga', me te whāngaitanga pūtea ki ngā kōkiri haepapa nā te iwi i hautū – tērā anō ngā mahi nunui e toe ana kia tutuki ai ngā wawata e tākina atu nei i te Rautaki, otirā ko ngā wāhanga mō te hanga raukaha, pūmanawa hoki, me te whakaurunga mai o te mātauranga Māori, ētahi wāhi tino hira.

Kei runga atu te hiahia mai i ngā kaupapa Kaikonihi-Kore me ngā kōkiri rangahau kia whai wāhi mai te mana whenua, kia noho hoki rātou hei kaiahautū. Me mātua whakapakari hononga, whakapiki hoki ngā rōpū Kaikonihi-Kore i te whakapono ki ngā whānau, ki ngā hapū me ngā iwi, me te whakahōhonu i tō rātou raukaha, ō rātou pūmanawa hoki kia tuitui ki a ngāi Māori me ngā anga o te mātauranga, kia whakaata tūturu te kōkiri Kaikonihi-Kore i ngā hiahia mātāmua o ngā whānau, o ngā hapū me ngā iwi.

E kūmea ana ki roto i Kaikonihi-Kore 2050 ngā aronga rangahau, hangarau hoki o te matahuha o ngā whakahaere – ka nui te ahunga whakamua i roto i ngā tau e 5 mā ngā kōkiri rangahau, whanaketanga 50 neke atu (e tākina atu nei te hōhonutanga i te Tāpiritanga B). 



Figure 9: Te tohanga o ngā kōkiri puta noa i ngā tāhuhu me ngā huaputa. Ko ia ● hei tohu mō tētahi kōkiri kotahi.

whenua ki te tārei i ngā kaupapa tuatahi, ki te homai mōhiotanga hoki mō te mahere wā roa. Ka puta te whakatau mō te haere tonu, ki tua atu i te wāhanga whakawhanake, i mua i te Pipiri 2022. Ina ētahi tauira o ngā kaupapa rangahau o te kaupapa.

E whakamātautau ana te kaupapa mehemea ka taea te haepapa rawa i te toriura i te wāhi uaua o ngā maunga, tata ki te 2150 heketēa, i te taha whaka-te-uru o te Ikawhenua Malte Brun i te Whenua Rāhui o Aoraki Mount Cook. I kōwhiria ai tēnei wāhi hei pae nā te mea kei runga kē atu te nuinga o ngā takiwā tērā pea ka whakaekēa anō i te 2400 m te teitei, e karapotingia ana e te awa kōpaka, e iti iho ai pea te whakawhitenga mai o te toriura, ā, ka noho ērā wāhi hei tauārai maunga ki te whakaekenga anō.

Ka haere ngā mahi tārore mā runga i tētahi whatunga tirotiro, e whakamahi nei i ngā hangarau hou pēnei i ngā poapoa mīhini, me ngā kāmera ara kīrearea kia mōhiotia ai e hia ngā toriura i reira i tēnei takiwā maunga raungaiti, he pēhea hoki te tāmi kaikonihi i whakaheke ai i te maha. Mā tēnei rangahau ka pai ake te whakamahere a Te Manahuna Aoraki i ngā mahi tāmi kaikonihi hei raurangi, mō ēnei takiwā maunga.
