These desperately endangered dolphins need to be left alone, not pursued by yet more watercraft.

The noise they produce is very loud and can be heard from our house about 1.5 km offshore. The noise under water will be even louder. There is already a lot of daily traffic in the Lyttelton Harbour with the Black cat ferry, commercial fishing vessels as well as large container ships.

To protect our taonga endemic dolphins, no more commercial vessels to be given permits to operate. I strongly oppose the application.

We strongly oppose the application by Jet Junkies for a marine mammal permit. It is completely unacceptable to operate jet skis tours in dolphin areas and for dolphin viewing activities. Marine mammals are not playthings or toys for human entertainment. Lyttelton harbour area is habitat to vulnerable Hector's dolphin, other dolphin species, fur seals and whales.

Research has shown that regular interaction with humans/boats reduces the normal feeding and social behaviour of dolphins and can lead to reduced number of dolphins births and reduced survival of young – see studies undertaken in Bay of Islands (Northland), for example. Jet skis driven by inexperienced tourists and young or untrained people are likely to be a real safety hazard for marine mammals, and possibly other boats. I wish to object to Jet Junkies application for commercial operations from a vessel to view and swim with marine mammals.

I understand from the application that this is intended to include the viewing of Hector's dolphins in particular from a jet ski.

This proposal would appear to have potentially serious adverse effects that are contrary to both the relevant policies of the Department of Conservation legislation and also the Marine Mammals Protection Regulations 1992. The DOC website states that the conservation status of these dolphins is "nationally vulnerable". Of a list of "threats" to this species, three of them are given as "boat strike", "tourism" and "noise".

This proposal entails all three.

The application states that the jet skis cruise at 40kmh and have a maximum speed of 81kmh. They have no propellers but the engines make a lot of noise.

The Marine Mammals Protection Regulations 1992 states, under Sect 20, that;

d)"no person is to make a loud or disturbing noise near dolphins or seals" and e)"no vessel is allowed within 300 metres of a pod".

If the intent of the application is to allow the applicant to take tourists close enough to the dolphins for them to have a "close encounter" then these regulations would preclude that.

The dolphins habitat is already threatened by existing boating and shipping activities in Lyttelton Harbour, including the expansion of the port, and further harm should be discouraged.

The existing dolphins can already be seen from the Tug Lyttelton on Sundays in summer, and occasionally from the Black Cat ferries that ply the harbour. This is a chance encounter, and the dolphins choose when to surface and which boat to follow. It is totally inappropriate to allow a permit that would see them "hunted" by a pack of jet skis.

Submission requesting that the request for a permit for a Marine Mammal encounter by Jet Ski Junkies' - BE DECLINED

Thank you for the opportunity for commenting on the new proposal from Jet Ski, requesting the Department for a Marine Mammal watch experience.

Please take the time to read in detail, why we believe this should not be given the green light.

Approximately 100 Hector's dolphins frequent Lyttelton harbour and the surrounding bays, each day.

Around 20 individual dolphins can be detected in the harbour itself, at any one time.

Lyttelton harbour is the only industrial harbour in the world to have daily Hector's dolphin visits - which is a privilege.

During the past few years, the dolphins have had to navigate a vast array of industrial activities, from recreational boating, commercial and industrial shipping, operations, channel deepening and dredging, full cruise ship berth development and associated rammed and hammer piling, land reclamation, and the daily container wash down contaminants from the operational port and associated activities.

To add yet another unnecessary human-based activity to the mix, is just an extra stressor for our endemic dolphins.

In detail - Jet Skis are designed for speed and quick turns, and are not recommended as a safe vessel for dolphin watching, for either the jet ski driver, passengers, or for the marine mammals.

Hector's prefer predictability - engaging with boats that manoeuvres slowly - such as small sailing yachts, kayaks and the like.

New Zealand dolphin watching regulations state that boats shouldn't speed in areas known to be hot spots for cetaceans, and other marine mammals.

There is already a lot of dolphin watching opportunities - such as those using commercial boats designed to cause the least impact and are operated by experienced skippers.

These operators know the area well, the behaviours of the dolphins, their biology, and facts relating to their conservation.

Frequently, the cumulative impacts of anthropogenic activities are not considered, whereas, they should be.

such as:

1. Fishing
2. Aquaculture
3. Current area uses - such as the industrial port activities.
4. Underwater noise - readings should be documented for such permit submissions, such as the range of jet-ski operational noise.
5. Dredging, and the dumping of dredge spoils right outside Lyttelton harbour
6. Pollution, eg: antifouling paint in dredge spoils, sewerage, container wash down from the port operations, and other sources.
7. Racing, such as fast yachts and speed boats, and continuous daily ferry crossings.

Since 2014, I have been involved in the conservation of these dolphins, and am a staunch advocate for their protections - especially in Banks Peninsula.

In past 10 weeks alone, there have been at least 9 Hector's deaths (reported), and 1 Maui dolphin. That is a dolphin less in an already unstable population: Hector's are at just 30 percent their original biomass.

We must limit our human-based activities to make sure these creatures not only survive, but thrive.

I strongly believe that using JetSkis for the sole purpose of a tourism venture: viewing slow-moving, protected native dolphins, and orca, is not only senseless, the very concept is on the cusp of negligence.

If this permit is accepted, for any reason, I will be rallying up further support, and appealing that decision.
