Tēnā koe

Thank you for your Official Information Act request to the Department of Conservation, received on 04 August 2022 in which you asked for:

"a list of those councils who have not yet implemented the NZCPS 2010."

Our records (refer to Appendix 1) indicate that the following regional councils and unitary authorities have not yet implemented the NZCPS 2010 through their regional coastal plans:

- Waikato
- Gisborne
- Hawke's Bay
- Tasman
- Nelson
- West Coast
- Canterbury
- Otago
- Southland.

The best means of assessing the status of council plans is from the councils themselves.

DOC completed a <u>review of the effect of the NZCPS 2010</u> on RMA decision-making in 2017, which is available on the DOC website. This review highlighted that although implementation was well advanced in some places, that the issues were complex and that implementation of the NZCPS 2010 would occur gradually over a period of years. Resourcing issues have been identified as a factor impeding timely coastal planning processes by councils.
