

Tēnā koe s9(2)(a)

Thank you for your Official Information Act request to the Department of Conservation, received on 5 May 2023 in which you asked for:

"Please provide copies of any briefing papers, aides memoire, advice, memoranda or other documents which DOC has provided to Minister(s) or Cabinet since 1 January 2022 in connection with the Milford Opportunities Project, including in connection with the meeting with Dr Keith Turner on or around 7 March 2023 (23-M-9)."

On 24 May 2023, we extended the timeframe to respond to your request to 3 July 2023 due to the consultation required. Under section 15(1)(a) of the Official Information Act, I provided you with my decision about this request on 3 July 2023, and advised that you would be provided with the material by 13 July 2023.

The full list of documents that are in scope of your request are listed in Appendix A, which follows this letter and are contained in the attached PDF file.

Two briefings (items 23 and 24) have been withheld in full under section 9(2)(f)(iv) of the Official Information Act as they are under active consideration due to the recruitment process for the Board Chair being currently active. There are also a number of briefings that are already publicly available and are therefore not included and are refused under section 18(d) of the Official Information Act. Where this is the case, the website link to these briefings is noted in the table.

I have decided to release the relevant parts of the remaining documents subject to information being withheld under one or more of the following sections of the Official Information Act:

- personal information, including contact details of officials, under section 9(2)(a) to protect the privacy of natural persons, including deceased people,
- commercially sensitive information, under section 9(2)(b)(ii) to protect the
 commercial position of the person who supplied the information, or who is the subject
 of the information,
- information subject to an obligation of confidence, under section 9(2)(ba)(i) to protect the supply of similar information or information from the same source



- advice still under consideration, section 9(2)(f)(iv) to maintain the current constitutional conventions protecting the confidentiality of advice tendered by Ministers and officials,
- free and frank expression under section 9(2)(g)(i) to maintain the effective conduct of public affairs,
- advice subject to legal privilege, under section 9(2)(h) to maintain legal professional privilege.

In making my decision, I have considered the public interest considerations in section 9(1) of the Official Information Act and determined there are no public interests which outweigh the grounds for withholding.
