Thank you for your request to the Department of Conservation, received on 26 May 2023, in which you asked:

*Question 1: May I enquire about the current insured value of the building in 2023 please.* 

Question 2: May I have DoC's legal description / guardianship for the building in relation to our country's first National Park Legislation.

We have considered your request under the Official Information Act 1982.

Your questions and our responses are listed below:

1. May I enquire about the current insured value of the building in 2023 please.

The insured value is a maximum of \$10 million for all perils, excluding Natural Disasters which are insured for demolition costs only up to a maximum of \$2 million.

2. May I have DoC's legal description / guardianship for the building in relation to our country's first National Park Legislation.
