Thank you for your request to the Department of Conservation (DOC), received on 13 March 2025, in which you asked for:

- 1. The decision support document relating to 107310-FAU.
- 2. Any email correspondence to and from the technical advisor and decision-maker relating to the issue of 107310-FAU.
- 3. Any email correspondence to and from the technical advisor and decision-maker and the relevant QEII representative who worked on the application.

We have considered your request under the Official Information Act 1982 (the OIA).

Your questions and our responses are listed below:

1. The decision support document relating to 107310-FAU.

I have decided to release the Decision Support document for 107310-FAU to you in part. Please refer to Item 1 in the Document Schedule.

2. Any email correspondence to and from the technical advisor and decision-maker relating to the issue of 107310-FAU.

I have interpreted your request as being email correspondence between the technical advisor and the decision-maker. There was no email correspondence between the technical advisor and decision-maker relating to 107310-FAU. Your request is therefore refused under Section 18(e) of the OIA – the information does not exist.

For completeness I have decided to provide you with the technical assessment for 107310-FAU as Item 2 in the document schedule, which was developed by the technical advisor and provided to the decision maker to be considered as part of the Decision Support document. As noted in the Decision Support document (Item 1), while concerns were initially raised by the technical advisor, these were mitigated by the inclusion of a condition requiring the applicant to obtain a conservation covenant if the project went ahead (Item 2a and Item 1, paragraph 4 refer). Please refer to Item 2 in the Document Schedule.

3. Any email correspondence to and from the technical advisor and decision maker and the relevant QEII representative who worked on the application.



I have confirmed there was no QEII representative who worked on 107310-FAU. Your request is therefore refused under Section 18(e) of the OIA – the information does not exist.
