Thank you for your request to the Department of Conservation, received on 25 March 2025, in which you asked for:

- *A list of all NGOs which may be, but are not limited to Greenpeace, WWF (World Wild Life Fund) and Forest and Bird that received government funding in the 2023/24 and 2024/25 financial years.*
- *The total amount of funding provided by your Ministry to each NGOs.*
- *Copies of any reports or evaluations conducted on the effectiveness of this funding.*

We have considered your request under the Official Information Act 1982 (OIA).

NGOs and funding

The two tables, incorporated in our response, list the non-government organisations (NGOs) with a nationwide focus that we consider to be within scope and have received funding, during the financial years noted in your request.

Please note the Department's financial year runs from 1 July to 30 June. This means that the financial information set out in the two tables specific to the 2024/25 financial year is only up to the end of the third quarter, being 31 March 2025.

We also note that the spend detailed fluctuates due to the funding being unevenly distributed, depending on what each project requires and when; the duration of each project varying; and some projects concluding, with a corresponding decrease in funding.

Table One contains details of the NGOs who received funding via grants awarded. This includes grants for projects from the Jobs for Nature programme and the DOC Community Fund (DOCCF).

Reporting and evaluation

With respect to reports or evaluations connected to this funding, we advise that the Department actively seeks value for money from grants awarded and programmes funded to provide the best conservation outcomes possible within available budgets.

Reporting is undertaken to ensure projects/programmes are meeting their contractual obligations, but evaluation reports are not required by all funded projects/programmes. The reporting undertaken for individual projects receiving grants is unlikely to be for the sole purpose of determining effectiveness, per your request.

Jobs for Nature

Jobs for Nature is a \$1.185 billion programme in response to COVID-19 to create both nature-based employment and enduring environmental benefits between 2020 and 2025. Five government agencies administer the funding, of which the Department manages \$485.3 million over 225 projects across New Zealand. Jobs for Nature funding is evaluated as part of the cross-agency programme evaluation. This includes an independent multi-year evaluation, Te Ao Māori evaluation, economic and social impact assessments, and benefits case studies. As all the reports and evaluation material is either publicly available, or will be publicly released as it becomes available, provision of this information is refused per section 18(d) of the OIA, as it is or will become publicly available.

The DOCCF supports community-led conservation projects on public and private land. It is available for community groups, iwi and private landowners across New Zealand for projects that protect and restore New Zealand's threatened species and ecosystems.
