Thank you for your request to the Department of Conservation (DOC), received on 11 June 2025, in which you asked for:

- 1. A list of all the individuals, groups, organisations, agencies, and/or departments DOC consulted with regarding Fish & Game reforms, between January 1 and June 5 2025.
- 2. The dates on which these individuals, groups, organisations, agencies, and/or departments were consulted.
- 3. The time DOC spent in consultation with each of these individuals, groups, organisations, agencies, and/or departments.
- 4. Any associated documentation (eg, briefing documents, presentations, reports, written feedback, etc) exchanged between DOC and these individuals, groups, organisations, agencies, and/or departments.
 - NB: The request for associated documentation shouldn't include correspondence, only substantive information, such as briefings or commentary or written feedback attached to correspondence that outline ideas, recommendations or concerns about Fish & Game, or raise matters or suggestions about the reforms.
- 5. Any draft Fish & Game reforms and/or proposed wording provided to DOC officials by either Ministers or external parties.
- 6. Briefing documents sent to Ministers on changes to Fish & Game between January 1 and June 5 2025.
- 7. Feedback sent to DOC by Ministers on those briefing documents.

We have considered your request under the Official Information Act 1982 (the OIA).

On 30 June 2025 we extended the timeframe to respond to your request to 7 August 2025 (20 working days) due to the quantity of information sought and the consultation necessary.

Your questions and our responses are listed below.

In response to questions 1-4

For context, the work to improve Fish and Game New Zealand's (Fish and Game's) governance and organisation was developed by the former Minister for Hunting and Fishing, Hon Todd McClay.

Minister McClay initiated a targeted engagement approach, seeking views from all Fish and Game councils and 20 Post Settlement Governance Entities (PSGEs) who have a statutory relationship or arrangement with Fish and Game in their settlement act or deed. As part of this, in December 2024 Minister McClay sent letters to these Fish and Game Councils and PSGEs



seeking views on how Fish and Game could improve its governance and organisation. These views were gathered over December 2024 – February 2025.

In early 2025, Hon James Meager, Minister for Hunting and Fishing, agreed to progress this work and met with all Fish and Game councils to discuss their views. As this was led by the Minister, these engagements are not captured as part of this request.

DOC supported the Minister's engagement by reaching out to wider iwi and hapū who do not have a statutory relationship or arrangement with Fish and Game, and to support PSGEs wishing to provide verbal feedback to the Minister's request. These engagements, alongside agency consultation on the *Fish and Game New Zealand Governance and Organisational Improvements Amendment Bill* Cabinet paper, are in scope of your request.

DOC also consulted relevant agencies on the draft Cabinet paper and draft regulatory impact assessment, which are in scope of this request.

Table 1 below outlines who DOC engaged with, the dates and duration of these engagements, and any substantive documentation associated with these engagements.

Advice

5. Any draft Fish & Game reforms and/or proposed wording provided to DOC officials by either Ministers or external parties.

DOC did not receive any draft Fish and Game reforms or proposed wording from either Minister or external parties. This part of your request is therefore refused under section 18(e) of the Official Information Act, as the information requested does not exist.

6. Briefing documents sent to Ministers on changes to Fish & Game between January 1 and June 5 2025.

The documents captured by the question are listed in items 12-24 of the attached document schedule.

DOC has interpreted the request for 'briefing documents sent to Ministers on changes to Fish & Game between January 1 and June 5 2025' as substantive advice to Ministers on legislative changes to Fish and Game. For this reason, some material that provides information on Fish and Game reforms (e.g. to support external meetings), but does not provide new or substantive advice, has been considered out of scope.

7. Feedback sent to DOC by Ministers on those briefing documents.

DOC primarily receives feedback from the Minister for Hunting and Fishing through regular meetings. The most substantive feedback is referenced in briefing 25-B-0147 [item 18].

Information release

I have decided to release the relevant parts of the documents identified above, subject to information being withheld under one or more of the following sections of the OIA, as applicable:

- personal information, under section 9(2)(a) to protect the privacy of natural persons, including deceased people,
- advice still under consideration, section 9(2)(f)(iv) to maintain the current constitutional conventions protecting the confidentiality of advice tendered by Ministers and officials,
- free and frank expression under section 9(2)(g)(i) to maintain the effective conduct of public affairs,
- advice subject to legal privilege, under section 9(2)(h) to maintain legal professional privilege, and
- out of scope.

In making my decision, I have considered the public interest considerations in section 9(1) of the OIA and determined there are no public interests that outweigh the grounds for withholding.

You are entitled to seek an investigation and review of my decision by writing to an Ombudsman as provided by section 28(3) of the OIA.
