Thank you for your request to the Department of Conservation (the Department), received on 18 December 2024, in which you asked for:

'All communications, reports, and memos from DOC regarding the latest Government funding injection to the Mount Ruapehu skifields and plans on what to do with the Whakapapa skifield.

Please include communications with Ministers and Ministerial offices.'

We have considered your request under the Official Information Act 1982 (the Act).

On 9 January 2025, you refined your request to all communications, reports, and memos from DOC within the timeframe of 1 October – 18 December 2024.

On 27 January 2025, we extended the timeframe to respond to your request to 17 February 2025 due to consultations necessary to make a decision on the request.

Please note that while decisions have been made at Cabinet to provide funding to Whakapapa Holdings for ownership of the Whakapapa ski field, this is conditional on a concession being granted and the conditional deal being finalised.

We have determined that the documents outlined in *Table 1 – Schedule of documents* are within the scope of your request.

I am releasing the relevant parts of the documents listed in Table 1, subject to information being withheld under one or more of the following sections of the Act, as applicable:

 personal contact details of officials, under section 9(2)(a) – to protect the privacy of natural persons,

- commercially sensitive information, under section 9(2)(b)(ii) to protect the
 commercial position of the person who supplied the information, or who is the subject
 of the information,
- advice still under consideration, section 9(2)(f)(iv) to maintain the current constitutional conventions protecting the confidentiality of advice tendered by Ministers and officials.
- free and frank expression under section 9(2)(g)(i) to maintain the effective conduct of public affairs,
- advice subject to legal privilege, under section 9(2)(h) to maintain legal professional privilege, and
- confidential information, under section 9(2)(j) to enable the Crown to negotiate without disadvantage or prejudice.

In making my decision, I have considered the public interest considerations in section 9(1) of the Act and determined there are no public interests that outweigh the grounds for withholding.

You are entitled to seek an investigation and review of my decision by writing to an Ombudsman as provided by section 28(3) of the Act.
