#### Kia ora

I am the new Fast-track Applications Manager and hope to connect with you next year. The purpose of this email is to update you on new information we have received from MfE and a workstream that may occur early next year.

We have received a list from MfE of Fast-track Projects likley to be lodged with EPA during February and early March. The dates have been provided by the Applicants and may change.

One of the projects that may be lodged on 28 February 2025 is Matakanui Gold Ltd, Bendigo-Ophir Gold Project (FTA107). From the limited information made available they may require DoC input on:

- Conservation Covenant
- Lizards
- Vegetation

I have included a link to information on the MfE website <u>Fast-track Schedule 2 Projects .pdf</u> and attached a PDF of an initial assessment made by the Fast-track Project Team from the limited information available.

I have also attached a document summarising DoC touchpoints on applications.

#### Update and expectations of DoC

- The Fast-track Approvals Bill had its third reading on 17 December and will be enacted as soon as it receives Royal Assent. This may be pre-Christmas.
- The Bill will come into effect immediately upon enactment, however, applicants are not able to lodge applications for referral or approvals until 7 February 2025.
- Applicants are required to do some consultation before lodging substantive applications and this may occur from Royal Assent.
- From 7 February applicants for projects listed in Schedule 2 will be able to apply directly to the EPA to have their projects assessed by expert panels.
- The EPA will seek input from DoC on to undertake a completeness check (15 working days for this to be completed) and (if the application is complete) pass it to a panel convener to stand up a panel.
- There is no prescribed time for the Panel appointment.
- The Panel Convener may require a report from DoC after the completeness check.
- The Panel have 10 working days to seek comments from DoC where relevant.
- If DoC have to provide a report, it is required 10 working days after comment is invited
- DoC will be required to respond to the request for comment within the timeframe set.

During January we hope to stand up a Project Team to look through the information we have in preparation for the application being lodged. Can you please consider who may be the most relevant person (people) to work with on this. There is no action required now; I will contact you again early next year.

Kia ora koutou – fyi some background to the mining proposal at Bendigo Station to support the EDS meeting on Thursday.

Without knowing any specific interest EDS may have, the information below is general in nature and in parts probably more detail than you need. I'm happy to support on the day if needed.

In short, SSI has been across the Matakanui/Santana mining exploration works at Bendigo Station since they began in 2017. This is due to the MOC obligations wrt the s77 Reserves Act conservation covenant over the Bendigo freehold lands. The covenant requires the MOC approval (delegated locally) for any exploration or mining on or under the land. We have not been involved in the plans for the mining phase which we understand are still being worked up in preparation for their application to either into the RMA or FT process.

### 1. Bendigo Station - general

- Bendigo Station is a high-country station in Central Otago, located generally within an area between the Cromwell-Tarras highway and the Thomsons Saddle road (see maps).
- It has been notable for its historic gold mining, pastoralism and in more recent times for Shrek the very woolly lost sheep.
- An early tenure review process through the mid-1990's resulted in the station splitting into a mix of freehold lands and the creation of the adjoining Historic and Scenic Reserves and the Bendigo Conservation Area, administered by Te Papa Atawhai.
- The freehold lands are subject to a s77 Reserves Act conservation covenant, signed in 2000. See attached. In short, the covenant objectives are to protect

- and enhance the natural character, native flora and fauna, ecological character, landscape and historic values of this privately owned land while allowing for its continued farming.
- The conservation covenant has been subject to recent OIA's. A redacted version in the public arena is found at <u>Bendigo Station - a Official Information</u> <u>Act request to Department of Conservation - FYI</u>

#### 2. Matakanui Gold Ltd

- In 2017 Matakanui Gold Ltd (MGL) sought to undertake initial and relatively minor (6 x 20m long trenches) exploratory gold mining activity at Bendigo Station.
- Condition 3(1)(d) of the covenant states that the Landowners will not carry out or allow to be carried out without the Ministers prior approval: Any prospecting or mining for minerals, coal or other deposit on or under the land
- Condition 3(4) requires that The Minister will have regard to the objectives of this Deed when considering any request for approval under this clause and will not unreasonably decline approval
- The MOC (delegated to the Central Otago Operations Manager) approved Bendigo Station to allow for this activity to be undertaken, subject to restoration.
- In 2018 approval was given to allow for 50 exploratory drill holes for core sampling, subject to a number of conditions
- In 2019 and 2021 approval was sought for relatively short temporary tracks to be built branching off the established farm roads, including in the 'Rise and Shine' area of the station, to allow for their mobile rigs to access sites to drill their test-cores.
- Given the temporary nature of the activity, the supporting values reports, internal technical advice and conditions of approval to avoid heritage sites, native flora and for restoration to the previous landform and cover immediately upon completion, this activity was given the Departments approval.
  - In 2022 more temporary tracks were applied for, with their attention focusing on the 'Rise and Shine' part of the station.
- The 'Rise and Shine' part of the station has its own clause in the covenant specifically to protect public access, allow for interpretation, and to protect from woody vegetation, forestry and tracks.
- In the course of considering the 2022 request it became apparent that only a limited amount of the temporary tracks had been immediately restored, with those remaining being sought to be in-situ for longer than expected, as MGL re-visit previous sites for supplementary drilling, with the extent of this determined as their results are understood.

- While acknowledging this operational reality, Te Papa Atawhai approved only a reduced scope of the 2022 application with notice that no future approvals would be given in the 'Rise and Shine' area of the station, as although in the Departments view while temporary tracks may be acceptable here, more permanent ones are not.
- To provide clarity, the covenant was amended in 2023 to allow for temporary tracks in the 'Rise and Shine' area subject to a suitable restoration and enhancement programme (see attached)
- In August 2024 approvals were given for Minimum Impact Activity (survey/mapping/samples) in surrounding conservation lands.

### 3. Santana Minerals Ltd and the Bendigo-Ophir Project

- MGL was purchased by Santana Minerals in 2020 <u>The Discovery Santana Minerals</u>
- The current interest is focused on the "Rise and Shine" area within Bendigo Station – see General 2 — Santana Minerals





1. General Background of our involvement to date

See the attachment sent to Ruth ahead of attending an EDS conference late last year – general info about our role/involvement to date, which mostly has been to consider/authorise the exploratory mining works 2017-24 as a consequence of our role with the s77 Reserves Act Covenant over the lands here. We were also involved in 2023-24 in a separate RMA consent application for an unrelated subdivision adjoining here that included some of the covenant area. Our RMA team managed that process and assembled a team of the usual suspects to understand the values etc – see below. In August 2024 approvals were given to Matakanui/Santana for Minimum Impact Activity (survey/mapping/samples) in the surrounding conservation lands.

2. The Covenant

The covenant was agreed to in 2000 following an early version of the tenure review process. Along with the covenant, the TR process established the adjoining parcels of what are now pcl. Some general media background to the TR outcomes is described in Rural Delivery

The covenant itself is embedded in the email to Ruth attached above. It covers the entirety of the Bendigo station lands, sets out the conservation objectives that the land is to be managed for, and includes specific clauses to protect the particular values of the Rise and Shine area, which by chance is the area of focus for the mining interest.

3. Values information

In terms of background to the values here, there are three different layers of information we hold:

(i) From the TR process of the 1990's

Hi Susan and your team and welcome into the role.

(Hi Rick – just FYI unless you have any wisdom on this query).

Susan - I am aware that you are across the Sanatana/Bendigo FT proposal as one of the first ones likely to be worked up in Feb.

Helpfully, locally we are across the background on this activity, having been involved in authorising their exploratory works under the conservation covenant provisions over the last few years; although we are not across any of the detail about their proposed actual mining phase.

Anyway - the *actual* reason for getting in touch with you is to seek some advice about an approach we've just had from a local community group (Sustainable Tarras) to present their interests to the Otago Conservation Board about this proposal. Boards have a standing agenda item 'Public Forum' designed for this sort of thing

Somewhere in my memory in the run up to the end of the year I recall advice (from somewhere/someone that I can't now find) that we should be cautious about this with FT proposals with boards, noting the Conservation Boards have a statutory role under the FTA and will be invited to comment via section 53(2)(m) and Schedule 6 (44).

As it happens, Santana presented to the OCB in a similar fashion in the 'Public Forum' session back in October.

Given Santana has presented to the OCB and that boards are an independent body appointed to represent the wider public interest, I can't see why we would be concerned or feel there is any conflict about interested parties presenting to boards – in fact I would have thought that would be welcome for them to be better informed – they will still form their own views when the time comes.

But before we go ahead and reply to the request from Sustainable Tarras (see attached) I just thought best to check in with you in case I have missed a memo here.

In addition to what is contained in the first attachment (the broad outline and key documents and key people who have already worked on this) there are a large number of emails and letters that relate to the exploratory authorisations 2017-24 if you need all those also.

Thanks for the email and it is topical as Joanne Liew is also in contact with Santana and copied me into an email yesterday. We don't have a Fast-track project lead for this as the fast-track team hasn't received a request for pre-lodgement consultation for this project. I can't advise on whether to seek advice from the expert below. The Fast-track timeframes are tight and planning ahead, as you are, sounds very sensible to me.

I am not sure I am being helpful however in short, I think this is not about whether to seek the expert input, but more on how to pay for it.

The things you need to consider is how we cost recover under Fast-track and what if the applicant doesn't file the application and it doesn't enter the Fast-track process. The process for this is on our website <u>Fast-track</u>: <u>Permissions</u>. Once this process is initiated, we can cost recover, for all pre-lodgement work completed by DOC.

Once an applicant has requested pre-lodgement consultation (via forms on the website) we can start recovering costs, alternative is the cost of the expert is covered from other budgets. I know other areas of BHV have set up contracts with specialist they think they

may require input from, at short notice, so that once required under Fast-track they can access these resources easily.


