Thank you for your requests to the Department of Conservation (DOC), received on 07 May 2025, in which you asked for:

'I would like to request a copy (sent as a PDF) of all current concession & permission documents between the Department of Conservation and NZSki as they relate to Coronet Peak Ski area.

I would like to request a copy (sent as a PDF) of all current concession & permission documents between the Department of Conservation and NZSki as they relate to The Remarkables Ski area, Rastus Burn Recreation Reserve Queenstown & the Doolans Basin

I can see online some discussion/documents relating a new application from NZSki for a concession in 2019-2021, but I assume this concession (lease, licence and easement) has been granted and a complete document is now available.'

We have considered your requests under the Official Information Act 1982 (the OIA).

On 13 May 2025 you clarified the following aspects of your request and noted:

- For both queries you seek the current lease, licence and easement concession document and any variations for each ski field. You noted that according to information available online, you understand these comprise of:
  - o 74167-SKI for Coronet Peak
  - o 96118-SKI for Remarkables, plus:
    - OT-34108-SKI Lease for re-alignment of access road entering into car parks & redevelopment of car parks; and
    - OT-34109-SKI Easement Curvey Basin Chairlift, snow making & trail development into Curvey Basin; and
    - 49957-SKI Easement
    - 100472-OTH for the Shadow Basin Chairlift from 2022/2023.
- You do not seek email correspondence associated with these concessions.



- You are not interested in personal contact details or commercially sensitive information associated with these concessions.

Your questions and our responses are listed below:

1. I would like to request a copy (sent as a PDF) of all current concession & permission documents between the Department of Conservation and NZSki as they relate to Coronet Peak Ski area

Material in scope of this aspect of your request is provided and accompanies our response as Attachment 1 (Items 1 - 7). For a detailed summary of documents provided please refer to the document schedule table.

As per your clarification, material provided includes variation documents associated with current (active concessions) at this location. This also includes all authorised activities on the mountain as they relate to NZSki.

Please note that Concession 100689-OTH is not provided. Although the concession had been granted it has not been executed/counter signed and currently remains under negotiation. Until negotiations are concluded and the concession counter signed, it is not considered active.

2. I would like to request a copy (sent as a PDF) of all current concession & permission documents between the Department of Conservation and NZSki as they relate to The Remarkables Ski area, Rastus Burn Recreation Reserve Queenstown & the Doolans Basin

Your clarification email listed the Remarkables concession 96118-SKI, however this application is still under consideration and is not considered as active, therefore is not in scope of your request. Until a decision is made on 96118-SKI, the active Remarkables permissions are 100472-OTH, OT-34108-SKI, OT-34109-SKI and 49957-SKI.

Material in scope of this aspect of your request is provided and accompanies our response as Attachment 2 (Items 1 - 16). For a detailed summary of documents provided please refer to the document schedule table.

As per your clarification, material provided includes variation documents associated with current (active concessions) at this location. This also includes all authorised activities on the mountain as they relate to NZSki.

I have decided to release the relevant parts of the documents listed in the document schedule table, subject to information being withheld under one or more of the following sections of the OIA, as applicable:

- personal information, under section 9(2)(a) to protect the privacy of natural persons, including deceased people,
- confidential information, under section 9(2)(j) to enable the Crown to negotiate without disadvantage or prejudice.
- information which may prejudice the maintenance of the law, including the prevention of offences, under section 6(c).

In making my decision, I have considered the public interest considerations in section 9(1) of the OIA and determined there are no public interests that outweigh the grounds for withholding.

You are entitled to seek an investigation and review of my decision by writing to an Ombudsman as provided by section 28(3) of the OIA.
