

### OIAD-5134 – Question 3

*How many non-prosecution outcomes, such as warning letters, instant fines, or other mechanisms has your agency implemented/imposed between 1 January 2020 and the current date (please break down by year, legislation and outcome if possible)?*

#### Response:

Application of the compliance database (CLEWorks / Pūnaha Tūtohu) commenced on the 4<sup>th</sup> of September 2020. We are unable to report on incidents prior to this commencement date.

The data below has a date range between 4<sup>th</sup> September 2020 and 15<sup>th</sup> May 2025.

- Since 04/09/2020, there has been 8690 logged compliance incidents/events.
- From these logged incidents, 2368 offences were established.  
2076 of these progressed to non-prosecution outcomes, as summarised below:
