Thank you for your request to the Department of Conservation (DOC), received on 15 April 2025, in which you asked for:

"I have been informed by HDC that your department has issued OGM with either licenses, permits, consents relating to their proposed North Project.

"OceanaGold also hold a range of other licences, permits and consents issued by New Zealand Petroleum and Minerals, the Department of Conservation and the Waikato Regional Council. Hauraki District Council has also granted OceanaGold a Licence to Occupy the unformed road reserve for specific purposes."

Could you please provide me a copy of any you have issued?"

We have considered your request under the Official Information Act 1982 (the OIA). On 23 April 2025 you clarified your request advising:

"I wish to know what leases etc. DOC has given Oceana Gold over the land for access etc. for their future North Project, please. Plus maps identifying this land. Plus what you have permitted the land to be used for."

The Waihi North Project is a Fast Track application currently being assessed by the Environmental Protection Authority (EPA). Given this, the Department has not made any decisions related to that project. I regret that I am not able to provide you with the information you seek because the information does not exist. I am therefore refusing your request under section 18(e) of the OIA.

We can, however, provide a list of the permissions the Department has granted to OceanaGold Limited (OGL). This information is provided in the table in **Appendix 1**, below.



You are entitled to seek an investigation and review of my decision by writing to an Ombudsman as provided by section 28(3) of the OIA.
