Thank you for your request to the Department of Conservation (DOC) received on 15 September 2025, in which you asked for:

"copies of all active permits to cull or disturb game birds that DOC has issued in your [the Auckland] region. You mention the existing permit [100618-FAU] is dated, but presumably still active? I would also appreciate an outline of any consultation undertaken with Fish & Game as statutory managers of game birds, prior to the issuance of these permits."

We have considered your request under the Official Information Act 1982 (the OIA).

On 10 October 2025, we extended the timeframe to respond to your request to 4 November 2025, due to consultations necessary to make a decision on the request.

The three parts of your request and our responses are listed below.

copies of all active permits to cull or disturb game birds that DOC has issued in your [the Auckland] region.

We have interpreted your request to be for all active Wildlife Act 1953 permits which feature gamebirds within the Auckland region. In scope material associated with this question is provided in the document schedule below. We have not included permits in scope which are issued to any Fish & Game Council within New Zealand, as this information has already been provided to your organisation. If you would like another copy of any of these permits, please let DOC know.

I have decided to release the relevant parts of the documents listed in the document schedule, subject to personal information being withheld under section 9(2)(a) of the OIA – to protect the privacy of natural persons, including deceased people.

In making my decision, I have considered the public interest considerations in section 9(1) of the OIA and determined there are no public interests that outweigh the grounds for withholding.

You mention the existing permit [100618-FAU] is dated, but presumably still active?

As advised on 18 September 2025, Permit 100618-FAU was issued to Auckland International Airport Ltd on 14 February 1990 and is currently active.

I would also appreciate an outline of any consultation undertaken with Fish & Game as statutory managers of game birds, prior to the issuance of these permits.



Of the identified permits outlined in the document schedule, records indicate that DOC has consulted with Fish & Game on 91215-FAU, 91575-FAU, and 91576-FAU. Additionally, I understand the concessionaire Auckland International Airport Limited consulted with Fish & Game regarding 97658-FAU.

Under the Wildlife Act 1953, there is no statutory requirement for DOC to conduct consultation with stakeholders or interested parties when assessing wildlife permit applications. Instead, the decision to consult is determined on a case-by-case basis, taking into account factors such as the species involved, the potential ecological and recreational impact, and any relevant statutory obligations.

You are entitled to seek an investigation and review of my decision by writing to an Ombudsman as provided by section 28(3) of the OIA.
