

## REVISED WARO LAND ACCESS RECOMMENDATIONS FOR FEEDBACK March – April 2022

### Background

In 2018, the Department began a process to review the 2015 national WARO land schedule and operating limits to undertake certain wild animal control activities on public conservation land. This included considering feedback from stakeholders on recommended changes and, once finalised and approved, forms the basis upon which a National WARO Concession is issued to WARO operators.

Recommended changes were first made available for feedback in June and July 2018. 430 submissions were received and considered by a national panel (comprising legal, technical and concessions staff). Subsequent amendments, including additional new land, were made available for feedback from December 2018 to February 2019 but limited only to those that submitted on the first round. 63 submissions were received and considered. Little progress has been made since then.

### Purpose of a third round of consultation

This third round of consultation is intended to provide a final opportunity for any potentially affected person to provide feedback on the second round of consultation recommendations, with some more recent amendments, to help move the process to completion. Feedback will again be considered by the panel and a report on submissions and final recommendations provided to the decision-maker.

### Additional information on land recommendations

Feedback was assessed against the Wild Animal Control Act, Deer Control Policy, Conservation Act and other legislation as appropriate, relevant statutory planning documents, wild animal information and health and safety considerations. The national panel made recommendations based on all this information.

Proposed WARO access changes not listed in this document, or the previous consultation rounds, will be recommended to remain and will be presented along with the outcome of this round to the decision-maker for a final decision.

### In this document

The majority of the proposed recommendations in this document are a re-circulation of the second round recommendations but with some more recent additions and corrections (presented in italics) and presentation of just two sections (see below) for easier understanding. Where applicable, draft land access recommendations previously consulted on are written in (brackets). The new or revised recommendations are written immediately below for each location. Areas of less than 20 ha have been excluded as these areas are generally the result of minor boundary adjustments, arising from improved mapping technology, or are too small to be considered for WARO access in their own right. Small areas adjoining public conservation land have been given the existing WARO access status of the adjoining land.

Section 1 contains access recommendations for new areas of public conservation land (since 2015), where the recommendations have changed from the first round of consultation.

Section 2 contains recommended changes access over existing public conservation land within the 2015 -2018 WARO schedule where these have been revised since the first round of consultation.
