This form is to be completed in conjunction with either Applicant Information Form 1a (longer term concession) or Applicant Information Form 1b (one-off concession) as appropriate.

Figure 1 Topographical map showing site in proximity to Havelock.




Figure 2 Aerial map showing the Site (licence area = blue polygons, lease area = orange polygon). Note: The sites are approximate. Includes an example of the walking tracks to be included in the guided walks, showing proximity to the Site.
