

# Application Form 8b Commercial Operations involving Marine Mammals Shore-based viewing activities

- If the application is approved, it is deemed to form part of the permit which is issued and must be complied with accordingly. Your application, therefore, must be clear, complete and accurate.

The Department will process the application and issue a permit if it is satisfied that the application meets all the requirements for granting a permit under the Marine Mammals Protection Regulations 1992.

Distances to each species:

Sea lions and fur seals at least 10m. More space if they are active and/or if there are pups.

How groups of people will be managed in the vicinity of seals or sea lions in particular to manage noise and behaviour:

- All customers are briefed on behaviour around mammals if they are encountered.
- No loud or disturbing noises will be allowed.
- Avoid coming between fur seals and the sea.
- Never attempt to touch seals or sea lions and never feed them.

Behaviour around breeding colonies, nurseries and pups:

- Extra care is taken not to disturb seals and sea lions on land when they have pups.
- Greater distance between observers and mammals
- Recognize distress or other signs (get up, growl) that show the mammals are not interested or disturbed, in which case the encounter will be aborted

What other actions you will take to minimise disturbance of the marine mammals:

Never proceed through a colony, use all available means to not disturb the mammals in their path or actions.

"Secondary purpose" means that viewing seals or sea lions is not the operation's main focus but will still be viewed if encountered; e.g. certain scenic cruises, tourist bus trips.
